8 An Act relating to roads, bridges and ferries;  
9 designating the Master Sergeant Houston K. Blackburn  
10 Memorial Highway; designating the PFC Lonnie D. Loyd,  
11 Jr. Memorial Highway; designating the George Freas  
12 Memorial Bridge; designating the Fallen Heroes  
13 Memorial Bridge; designating the 95th Division  
14 Memorial Highway; designating the E. A. Woods  
15 Memorial Highway; designating the Representative Opio  
16 Toure Memorial Highway; providing for placement of  
17 permanent markers; providing for codification; and  
18 declaring an emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified  
21 in the Oklahoma Statutes as Section 1698.60 of Title 69, unless  
22 there is created a duplication in numbering, reads as follows:

23 That portion of State Highway 7 from the Atoka city limits  
24 extending west to the Johnston County line shall be designated as  
the "Master Sergeant Houston K. Blackburn Memorial Highway". The  
Department of Transportation shall cause suitable permanent markers  
to be placed on the highway bearing that name.

SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.61 of Title 69, unless there is created a duplication in numbering, reads as follows:

That portion of State Highway 48 from the junction of State Highway 48 and State Highway 7 extending north to the Johnston County line shall be designated as the "PFC Lonnie D. Loyd, Jr. Memorial Highway". The Department of Transportation shall cause suitable permanent markers to be placed on the highway bearing that name.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.62 of Title 69, unless there is created a duplication in numbering, reads as follows:

The bridge on State Highway 31 approximately four (4) miles southwest of Ashland in Coal County shall be designated the "George Freas Memorial Bridge". The Department of Transportation shall cause suitable permanent markers to be placed on the bridge bearing that name.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.63 of Title 69, unless there is created a duplication in numbering, reads as follows:

The bridge crossing Bull Creek on East State Highway 60 approximately one (1) mile east of the junction of East State Highway 60 and State Highway 2 in Craig County shall be designated

1 the "Fallen Heroes Memorial Bridge". The Department of  
2 Transportation shall cause suitable permanent markers to be placed  
3 on the bridge bearing that name.

4 SECTION 5. NEW LAW A new section of law to be codified  
5 in the Oklahoma Statutes as Section 1698.64 of Title 69, unless  
6 there is created a duplication in numbering, reads as follows:

7 That portion of Interstate 44 located in Comanche County from  
8 the junction of Interstate 44 and State Highway 7 extending north to  
9 mile marker 46 shall be designated as the "95th Division Memorial  
10 Highway". The Department of Transportation shall cause suitable  
11 permanent markers be placed on the highway bearing that name.

12 SECTION 6. NEW LAW A new section of law to be codified  
13 in the Oklahoma Statutes as Section 1698.65 of Title 69, unless  
14 there is created a duplication in numbering, reads as follows:

15 The portion of State Highway 46 from the junction of State  
16 Highway 46 and State Highway 15 extending south to the junction of  
17 State Highway 46 and the Sharon-Shattuck Road, shall be designated  
18 as the "E. A. Woods Memorial Highway". The Department of  
19 Transportation shall cause suitable permanent markers to be placed  
20 on the highway bearing that name.

21 SECTION 7. NEW LAW A new section of law to be codified  
22 in the Oklahoma Statutes as Section 1698.66 of Title 69, unless  
23 there is created a duplication in numbering, reads as follows:

1 The portion of Interstate 35 in Oklahoma City between Northeast  
2 23rd Street and Interstate 40 shall be designated as the  
3 "Representative Opio Toure Memorial Highway". The Department of  
4 Transportation shall place suitable permanent markers on the highway  
5 bearing that name.

6 SECTION 8. It being immediately necessary for the preservation  
7 of the public peace, health and safety, an emergency is hereby  
8 declared to exist, by reason whereof this act shall take effect and  
9 be in full force from and after its passage and approval.
