7 PROPOSED COMMITTEE SUBSTITUTE

8 An Act relating to schools; requiring State Board of
9 Education to adopt social studies core curriculum
10 with courses of instruction that include certain
11 subjects; requiring State Textbook Committee to adopt
12 textbooks incorporating certain subjects; amending 70
13 O.S. 2001, Section 1210.508, as last amended by
14 Section 8, Chapter 456, O.S.L. 2009 (70 O.S. Supp.
15 2009, Section 1210.508), which relates to certain
16 criterion-referenced tests; including certain
17 subjects in end-of-instruction test for United States
18 history; providing for codification; providing for
19 noncodification; and providing an effective date.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law not to be
22 codified in the Oklahoma Statutes reads as follows:

23 Section 2 and Section 3 of this act shall be known and may be
24 cited as the "Bill of Rights Education Act of 2010".

SECTION 2. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 11-103.6i of Title 70, unless
there is created a duplication in numbering, reads as follows:

1 A. The State Board of Education shall adopt a social studies
2 core curriculum with instruction for all students enrolled in the
3 public schools that includes the following subjects:

4 1. The Declaration of Independence;

5 2. The United States Constitution, including the Bill of
6 Rights;

7 3. Substantive selections from the Federalist Papers;

8 4. The Emancipation Proclamation;

9 5. The Gettysburg Address; and

10 6. George Washington's Farewell Address.

11 B. The State Textbook Committee, when adopting textbooks, shall
12 incorporate the provisions of subsection A of this section into the
13 criteria used to evaluate United States government, United States
14 history, and Oklahoma history textbooks.

15 SECTION 3. AMENDATORY 70 O.S. 2001, Section 1210.508, as
16 last amended by Section 8, Chapter 456, O.S.L. 2009 (70 O.S. Supp.
17 2009, Section 1210.508), is amended to read as follows:

18 Section 1210.508 A. 1. The State Board of Education shall
19 develop and administer a series of criterion-referenced tests
20 designed to indicate whether the state academic content standards,
21 as defined by the State Board of Education in the Priority Academic
22 Student Skills Curriculum, which Oklahoma public school students are
23 expected to have attained have been achieved. The Board may develop
24 and administer any criterion-referenced test in any subject not

1 required by federal law, contingent upon the availability of
2 funding. Students who do not perform at least at the proficient
3 level on tests shall be remediated, subject to the availability of
4 funding.

5 2. Contingent upon the availability of state and federal funds,
6 the Board, in accordance with federal law, shall administer
7 criterion-referenced tests for grades three and four in:

- 8 a. reading, and
- 9 b. mathematics.

10 3. Contingent upon the availability of funds, the Board shall
11 administer criterion-referenced tests for grade five in:

- 12 a. reading,
- 13 b. mathematics,
- 14 c. science,
- 15 d. social studies, which shall consist of the history,
16 Constitution and government of the United States, and
17 geography, and
- 18 e. writing of English.

19 4. Contingent upon the availability of state and federal funds,
20 the Board, in accordance with federal law, shall administer
21 criterion-referenced tests for grades six and seven in:

- 22 a. reading, and
- 23 b. mathematics.

24

1 In addition, the Board shall administer a criterion-referenced
2 test in geography in grade seven.

3 5. Contingent upon the availability of funds, the Board shall
4 administer criterion-referenced tests for grade eight in:

- 5 a. reading,
- 6 b. mathematics,
- 7 c. science,
- 8 d. social studies, which shall consist of the history,
9 Constitution, and government of the United States, and
- 10 e. writing of English.

11 The Board shall administer the tests for grade eight in reading
12 and mathematics online with raw score test results reported
13 immediately and complete results reported in less than two (2) weeks
14 beginning in the 2007-08 school year.

15 6. Each student who completes the instruction for English II,
16 English III, United States History, Biology I, Algebra I, Geometry,
17 and Algebra II at the secondary level shall complete an end-of-
18 instruction test, when implemented, to measure for attainment in the
19 appropriate state academic content standards in order to graduate
20 from a public high school with a standard diploma. All students
21 shall take the tests prior to graduation, unless otherwise exempt by
22 law. The State Board of Education shall administer the criterion-
23 referenced tests. The Board shall develop and field test the end-
24 of-instruction tests in English III, Geometry, and Algebra II during

1 the 2006-07 school year, implement the tests during the 2007-08
2 school year, and administer them each year thereafter. The Board
3 shall administer the multiple choice portion of the end-of-
4 instruction tests online with raw score test results reported
5 immediately and complete results reported in less than two (2) weeks
6 beginning in the 2008-09 school year.

7 The end-of-instruction tests shall serve the purpose of the
8 criterion-referenced tests as provided in paragraph 1 of this
9 subsection. The English II and English III end-of-instruction tests
10 shall include a writing component. The United States History end-
11 of-instruction test shall include multiple questions containing
12 fundamental principles in each of the following subjects: the
13 Declaration of Independence, the United States Constitution,
14 including the Bill of Rights, substantive selections from the
15 Federalist Papers, the Emancipation Proclamation, the Gettysburg
16 Address, and George Washington's Farewell Address. Students who do
17 not score at least at the proficient level shall be afforded the
18 opportunity to retake each test up to three (3) times each calendar
19 year until at least achieving at the proficient level. In order to
20 provide an indication of the levels of competency attained by the
21 student in a permanent record for potential future employers and
22 institutions of higher education, for students who enter the ninth
23 grade in or prior to the 2007-08 school year, school districts shall
24 report the highest achieved state test performance level on the end-

1 of-instruction tests on the student's high school transcript.
2 Beginning with students who enter the ninth grade in the 2008-09
3 school year, school districts shall report the student's performance
4 levels of proficient and above on the end-of-instruction tests and
5 any business and industry-recognized endorsements attained on the
6 student's high school transcript. Any student at the middle school
7 level who completes the instruction in a secondary course specified
8 in this paragraph shall be administered the appropriate end-of-
9 instruction test.

10 7. a. Each school district shall administer to each student
11 in the school district in grades three through eight
12 an assessment designed to assess the student in the
13 fine arts area in which the student has received
14 instruction.

15 b. Each school district shall prepare an annual report
16 for approval by the State Board of Education outlining
17 the fine arts assessment strategies used by the
18 district, when the assessments were administered, how
19 many students were assessed during the previous year,
20 and the results of the assessments.

21 B. 1. All criterion-referenced tests required by this section
22 shall measure academic competencies in correlation with the state
23 academic content standards adopted by the Board pursuant to Section
24 11-103.6 of this title and known as the Priority Academic Student

1 Skills Curriculum. The State Board of Education shall evaluate the
2 academic content standards to ensure the competencies reflect high
3 standards, are specific, well-defined, measurable, challenging, and
4 will prepare elementary students for next-grade-level course work
5 and secondary students for postsecondary studies at institutions of
6 higher education or technology center schools without the need for
7 remediation in core curriculum areas. All state academic content
8 standards shall reflect the benchmarks of the American Diploma
9 Project and the goal of improving the state average ACT score.

10 2. The State Department of Education shall annually evaluate
11 the results of the criterion-referenced tests. The State Board of
12 Education shall ensure that test results are reported to districts
13 in a manner that yields detailed, diagnostic information for the
14 purpose of guiding instruction and student remediation. As
15 improvements are made to the criterion-referenced tests required by
16 this section, the Board shall seek to increase the depth of
17 knowledge assessed for each subject. The State Board of Education
18 shall seek to ensure that data yielded from the tests required in
19 this section are utilized at the school district level to prescribe
20 reinforcement and/or remediation by requiring school districts to
21 develop and implement a specific program of improvement based on the
22 test results.

23 3. The State Board of Education in coordination with the
24 Educational Quality and Accountability Board shall review, realign,

1 and recalibrate, as necessary, the tests in reading and mathematics
2 in third through eighth grade and the end-of-instruction tests. The
3 State Board of Education shall determine the cut scores for the
4 performance levels on the end-of-instruction tests developed
5 pursuant to paragraph 6 of subsection A of this section, which shall
6 be phased in over a multi-year period. The State Board of Education
7 shall conduct an ongoing review to compare the end-of-instruction
8 test content and performance descriptors with those of other states.
9 Upon receipt of the review, the State Board of Education may adjust
10 the cut scores as necessary.

11 4. The State Board of Education, for the purposes of conducting
12 reliability and validity studies, monitoring contractor adherence to
13 professionally accepted testing standards, and providing
14 recommendations for testing program improvement, shall retain the
15 services of an established, independent agency or organization that
16 is nationally recognized for its technical expertise in educational
17 testing but is not engaged in the development of aptitude or
18 achievement tests for elementary or secondary level grades. These
19 national assessment experts shall annually conduct studies of the
20 reliability and validity of the end-of-instruction tests
21 administered pursuant to this section. Validity studies shall
22 include studies of decision validity, concurrent validity and the
23 validity of performance level cut scores.

1 C. 1. The State Board of Education shall set the testing
2 window dates for each criterion-referenced test required in
3 paragraphs 1 through 5 of subsection A of this section for grades
4 three through eight so that, with the exception of the writing
5 assessments, the tests are administered to students no earlier than
6 April 10 each year and so that the test results are reported back to
7 school districts in a timely manner. Each criterion-referenced test
8 required in paragraph 6 of subsection A of this section may be
9 administered to students at a time set by the State Board of
10 Education as near as possible to the end of the course. All results
11 and reports of the criterion-referenced test series required in
12 paragraphs 1 through 5 of subsection A of this section for grades
13 three through eight shall be returned to each school district prior
14 to the beginning of the next school year. The vendor shall provide
15 a final electronic data file of all school site, school district,
16 and state results to the State Department of Education and the
17 Office of Accountability prior to September 1 of each year. The
18 Department shall forward the final data files for each school
19 district and each school site in that district to the school
20 district. The Board shall ensure the contract with the testing
21 vendor includes a provision that the vendor report test results
22 directly to the Office of Accountability at the same time it is
23 reported to the Board.

1 2. State, district, and site level results of all tests
2 required in this section shall be disaggregated by gender, race
3 ethnicity, disability status, migrant status, English proficiency,
4 and status as economically disadvantaged, except that such
5 disaggregation shall not be required in a case in which the number
6 of students in a category is insufficient to yield statistically
7 reliable information or the results would reveal personally
8 identifiable information about an individual student. Each school
9 site shall notify the student's parents of the school's performance
10 levels in the Oklahoma School Testing Program as reported in the
11 Oklahoma Educational Indicators Program at the end of each school
12 year.

13 D. The State Board of Education shall be responsible for the
14 development, field-testing, and validation of the criterion-
15 referenced test series required in subsection A of this section. In
16 the interest of economy the Board shall adapt criterion-referenced
17 tests that have been developed by or in collaboration with other
18 states or are otherwise commercially available, or portions of such
19 tests, to the extent that such tests are appropriate for use in the
20 testing program to be administered to Oklahoma students.

21 E. The State Board of Education shall develop, administer, and
22 incorporate as a part of the Oklahoma School Testing Program, other
23 testing programs or procedures, including appropriate accommodations
24 for the testing of students with disabilities as required by the

1 Individuals with Disabilities Education Act (IDEA), 20 USC, Section
2 1400 et seq.

3 SECTION 4. This act shall become effective November 1, 2010.
