9 PROPOSED COMMITTEE SUBSTITUTE

10 An Act relating to roads, bridges and ferries;  
11 designating certain memorial highways; requiring  
12 permanent markers; providing for codification; and  
13 providing an effective date.

14  
15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 1698.60 of Title 69, unless  
18 there is created a duplication in numbering, reads as follows:

19 The portion of United States Highway 70 from the Bryan/Marshall  
20 county line extending west to the intersection of United States  
21 Highway 377 within the City of Madill limits shall be designated as  
22 the "Corporal Michael Eyre Thompson Memorial Highway". The  
23 Department of Transportation shall cause suitable permanent markers  
24 to be placed upon the highway bearing that name.

1 SECTION 2. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.61 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4 The portion of United States Highway 377 from the City of Madill  
5 limits south to the Oklahoma State line shall be designated as the  
6 "Sergeant Clint E. Williams Memorial Highway". The Department of  
7 Transportation shall cause suitable permanent markers to be placed  
8 upon the highway bearing that name.

9 SECTION 3. NEW LAW A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.62 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12 The portion of United States Highway 70 from the Bryan/Marshall  
13 county line east to the City of Durant limits shall be designated as  
14 the "Chief Warrant Officer Brady Rudolf Memorial Highway". The  
15 Department of Transportation shall cause suitable permanent markers  
16 to be placed upon the highway bearing that name.

17 SECTION 4. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 1698.63 of Title 69, unless  
19 there is created a duplication in numbering, reads as follows:

20 The portion of Scenic 77/County Line Road in Carter County from  
21 the junction of Scenic 77/County Line Road and State Highway 77  
22 extending east to the junction of Scenic 77/County Line Road and  
23 State Highway 77S shall be designated as the "Three Hero Highway:  
24 Honoring and In Memory of District Attorney Mitchell D. Sperry,

1 Sherriff Harvey Burkhart and Representative Terry Hyman". The  
2 Department of Transportation shall cause suitable permanent markers  
3 to be placed on the highway bearing that name.

4 SECTION 5. This act shall become effective November 1, 2010.
