1 "SECTION 1. AMENDATORY 26 O.S. 2001, Section 2-118, as  
2 last amended by Section 1, Chapter 83, 2nd Extraordinary Session,  
3 O.S.L. 2006 (26 O.S. Supp. 2009, Section 2-118), is amended to read  
4 as follows:

5 Section 2-118. A. ~~The~~ Except as provided by subsection C of  
6 this section the secretary of each county election board shall be  
7 paid an annual salary to be determined by the following schedule.  
8 However, the salary of a county election board secretary shall not  
9 fall below the level of the April 30, 2003, salary, and the salary  
10 of any person who is reappointed to the position of county election  
11 board secretary shall not fall below the salary received in the  
12 immediately preceding term, regardless of the number of active  
13 registered voters in the county. A county election board secretary  
14 serving on April 30, 2004, shall not receive a salary increase if  
15 said secretary is paid an amount greater than the salary indicated  
16 in this section according to the number of registered voters in said  
17 county. A county election board secretary shall not receive a  
18 salary increase while the county is under the administrative  
19 supervision of the State Election Board.

20 1. Beginning May 1, 2003 and ending April 30, 2007, the annual  
21 salary, payable monthly shall be:

1	15,001 to 17,500	\$26,252.45

7 2. Beginning May 1, 2007, the annual salary, payable monthly  
8 shall be:

10	0 to 10,000	\$22,667.69
11	10,001 to 15,000	\$23,507.68
12	15,001 to 17,500	\$27,565.07
13	17,501 to 25,000	\$30,901.43
14	25,001 to 50,000	\$37,639.29
15	50,001 to 75,000	\$47,433.39
16	75,001 to 150,000	\$53,141.82
17	150,001 or more	\$58,845.15

18 B. The salary and fringe benefits paid to each secretary shall  
19 be paid from county funds on a monthly basis and shall be reimbursed  
20 from funds appropriated by the Legislature for that purpose at a  
21 rate of not to exceed one hundred thirty-five percent (135%) of the  
22 above-specified salaries. Claims for said reimbursement shall be  
23 filed according to procedures prescribed by the Secretary of the  
24 State Election Board and approved by the Director of the Office of

1 State Finance. Said claims for reimbursement shall only be paid for  
2 actual expenditures made by the county. The number of registered  
3 voters, for the purposes of this section, shall be determined by the  
4 number of registered voters, excluding inactive voters, in the  
5 county on January 1, 1979, and every two (2) years thereafter.

6 C. County commissioners may provide supplemental funding for  
7 the offices and salaries of the county election board within their  
8 own county."
