19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3904, as
21 amended by Section 1, Chapter 26, O.S.L. 2003 (74 O.S. Supp. 2008,
22 Section 3904), is amended to read as follows:
