9 Sections 3905, as last amended by Section 2, Chapter  
10 24, O.S.L. 2009 and 3906, as last amended by Section  
11 20, Chapter 329, O.S.L. 2008 (74 O.S. Supp. 2009,  
12 Sections 3905 and 3906), which relate to recreating  
13 certain entities; recreating certain entities;  
14 modifying list of statutory entities subject to re-  
15 creation; and modifying termination date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3905, as  
18 last amended by Section 2, Chapter 24, O.S.L. 2009 (74 O.S. Supp.  
19 2009, Section 3905), is amended to read as follows:

20 Section 3905. The following statutory entities and their  
21 successors shall be terminated on July 1, ~~2010~~ 2014, and all powers,  
22 duties and functions shall be abolished one (1) year thereafter:

23 1. State Board of Licensure for Professional Engineers and Land  
24 Surveyors as created by Section 475.3 of Title 59 of the Oklahoma  
Statutes;

1           2. Oklahoma Accountancy Board as created by Section 15.2 of  
2 Title 59 of the Oklahoma Statutes;

3           3. The Board of Governors of the Licensed Architects, Landscape  
4 Architects and Registered Interior Designers of Oklahoma as created  
5 by Section 46.4 of Title 59 of the Oklahoma Statutes;

6           4. Oklahoma Funeral Board as created by Section 396 of Title 59  
7 of the Oklahoma Statutes;

8           5. Long-Term Care Facility Advisory Board as created by Section  
9 1-1923 of Title 63 of the Oklahoma Statutes;

10          6. Commission on Marginally Producing Oil and Gas Wells as  
11 created by Section 700 of Title 52 of the Oklahoma Statutes; and

12          7. ~~Minority Teacher Recruitment Advisory Committee as created~~  
13 ~~by Section 6-129.1 of Title 70 of the Oklahoma Statutes; and~~

14          ~~8.~~ Group Homes for Persons with Developmental or Physical  
15 Disabilities Advisory Board as created by Section 1430.4 of Title 10  
16 of the Oklahoma Statutes.

17          SECTION 2.           AMENDATORY           74 O.S. 2001, Section 3906, as  
18 last amended by Section 20, Chapter 329, O.S.L. 2008 (74 O.S. Supp.  
19 2009, Section 3906), is amended to read as follows:

20          Section 3906. The following statutory entities and their  
21 successors shall be terminated on July 1, 2011, and all powers,  
22 duties and functions shall be abolished one (1) year thereafter:

23          1. Polygraph Examiners Board as created by Section 1455 of  
24 Title 59 of the Oklahoma Statutes;

1           2. State Board of Osteopathic Examiners as created by Section  
2 624 of Title 59 of the Oklahoma Statutes;

3           3. Board of Podiatric Medical Examiners as created by Section  
4 137 of Title 59 of the Oklahoma Statutes; ~~and~~

5           4. Oklahoma State Athletic Commission as created by Section  
6 604.1 of Title 3A of the Oklahoma Statutes; and

7           5. Minority Teacher Recruitment Advisory Committee as created  
8 by Section 6-129.1 of Title 70 of the Oklahoma Statutes.
