"An Act relating to boating safety; amending 63 O.S. 2001, Sections 4210, as last amended by Section 2, Chapter 95, O.S.L. 2008 and 4210A, as renumbered by Section 9, Chapter 393, O.S.L. 2003 (63 O.S. Supp. 2008, Sections 4210 and 4210.6), which relate to vessel operation; limiting certain vessel usage; modifying alcohol concentration amounts; allowing for certain tests to determine substance concentration; defining terms; authorizing test type; providing consequences; allowing for medical exceptions; authorizing use of test specimens; qualifying persons authorized to administer tests; limiting liability; providing for independent test analysis; allowing admission of test results in civil actions; allowing for exceptions to test refusal; authorizing use of laboratory findings; defining levels of alcohol concentration for evidence purposes; allowing for use of all evidence; providing for codification; providing an effective date; and declaring an emergency."
