8 An Act relating to the State Board of Education;  
9 reappropriating and redesignating a certain amount of  
10 appropriations for Academic Achievement Awards  
11 purposes; reappropriating and redesignating a certain  
12 amount of appropriations for certain SoonerStart  
13 Early Intervention Program services; making  
14 appropriations exempt from budget and category  
15 limits; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. REAPPROPRIATION AND REDESIGNATION The amount  
18 of Two Million Two Hundred Four Thousand Thirty-seven Dollars  
19 (\$2,204,037.00), of the original appropriation of Four Hundred  
20 Thirty Million Five Hundred Fifty-four Thousand One Hundred Twenty-  
21 eight Dollars (\$430,554,128.00), appropriated to the State Board of  
22 Education by Section 6, Chapter 92, O.S.L. 2008, from any monies not  
23 otherwise appropriated from the General Revenue Fund of the State  
24 Treasury, for the fiscal year ending June 30, 2009, for support of  
public school activities and allocated in Section 1, Chapter 264,  
O.S.L. 2008, for Education Leadership Oklahoma, is hereby

1 reappropriated and redesignated for the purpose of Academic  
2 Achievement Awards. If, on the date this act is approved, any of  
3 the amount originally appropriated, as adjusted by expenditures,  
4 encumbrances and transfers, results in an unencumbered balance less  
5 than the reappropriated and redesignated amount, that reappropriated  
6 and redesignated amount is reduced to the unencumbered amount.

7 SECTION 2. REAPPROPRIATION AND REDESIGNATION The amount  
8 of One Million Three Hundred Fifty-four Thousand Three Hundred  
9 Twenty-nine Dollars (\$1,354,329.00) of the original appropriation of  
10 Four Hundred Thirty Million Five Hundred Fifty-four Thousand One  
11 Hundred Twenty-eight Dollars (\$430,554,128.00), appropriated to the  
12 State Board of Education by Section 6, Chapter 92, O.S.L. 2008, from  
13 any monies not otherwise appropriated from the General Revenue Fund  
14 of the State Treasury, for the fiscal year ending June 30, 2009, for  
15 the support of public school activities and allocated in Section 1,  
16 Chapter 264, O.S.L. 2008, for Staff Development, is hereby  
17 reappropriated and redesignated for the purpose of funding direct  
18 services of the SoonerStart Early Intervention Program. If, on the  
19 date this act is approved, any of the amount originally  
20 appropriated, as adjusted by expenditures, encumbrances and  
21 transfers, results in an unencumbered balance less than the  
22 reappropriated and redesignated amount, that reappropriated and  
23 redesignated amount is reduced to the unencumbered amount.

1       SECTION 3. The appropriations made by this act shall not be  
2 subject to fiscal year agency budget and category limitations.

3       SECTION 4. It being immediately necessary for the preservation  
4 of the public peace, health and safety, an emergency is hereby  
5 declared to exist, by reason whereof this act shall take effect and  
6 be in full force from and after its passage and approval.
