10 CONFERENCE COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma State Bureau of
12 Narcotics and Dangerous Drugs Control; amending
13 Sections 110 and 111 of Enrolled Senate Bill No. 216
14 of the 1st Session of the 52nd Oklahoma Legislature,
15 which relate to appropriations; revising
16 appropriation amounts; making an appropriation;
17 stating purpose; making appropriation nonfiscal;
18 making appropriation exempt from certain agency
19 category and budget limits; providing an effective
20 date; and declaring an emergency.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. AMENDATORY Section 110 of Enrolled Senate
23 Bill No. 216 of the 1st Session of the 52nd Oklahoma Legislature is
24 amended to read as follows:

Section 110. There is hereby appropriated to the Oklahoma State
Bureau of Narcotics and Dangerous Drugs Control from any monies not
otherwise appropriated from the General Revenue Fund of the State

1 Treasury for the fiscal year ending June 30, 2010, the sum of ~~Four~~
2 ~~Million Two Hundred Ninety nine Thousand Seven Hundred Twenty two~~
3 ~~Dollars (\$4,299,722.00)~~ Four Million Nine Hundred Forty-nine
4 Thousand Seven Hundred Twenty-two Dollars (\$4,949,722.00) or so much
5 thereof as may be necessary to perform the duties imposed upon the
6 Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by
7 law.

8 SECTION 2. AMENDATORY Section 111 of Enrolled Senate
9 Bill No. 216 of the 1st Session of the 52nd Oklahoma Legislature is
10 amended to read as follows:

11 Section 111. There is hereby appropriated to the Oklahoma State
12 Bureau of Narcotics and Dangerous Drugs Control from any monies not
13 otherwise appropriated from the General Revenue Fund of the State
14 Treasury for the fiscal year ending June 30, 2008, the sum of ~~Two~~
15 ~~Million Dollars (\$2,000,000.00)~~ One Million Three Hundred Fifty
16 Thousand Dollars (\$1,350,000.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Oklahoma State
18 Bureau of Narcotics and Dangerous Drugs Control by law.

19 SECTION 3. There is hereby appropriated to the Oklahoma State
20 Bureau of Narcotics and Dangerous Drugs Control from the General
21 Revenue Fund of the State Treasury for the fiscal year ending June
22 30, 2008, the sum of Six Hundred Fifty Thousand Dollars
23 (\$650,000.00) or so much thereof as may be necessary to perform the

1 duties imposed upon the Oklahoma State Bureau of Narcotics and
2 Dangerous Drugs Control by law.

3 SECTION 4. The appropriation made by Section 3 of this act
4 shall not be subject to fiscal year limitations and shall be
5 available for encumbrance and expenditure purposes for a period of
6 thirty (30) months from the date this act is approved.

7 SECTION 5. The appropriation made by Section 3 of this act
8 shall not be subject to fiscal years 2009 and 2010 agency category
9 and budget limits.

10 SECTION 6. Sections 1 and 2 of this act shall become effective
11 July 1, 2009.

12 SECTION 7. It being immediately necessary for the preservation
13 of the public peace, health and safety, an emergency is hereby
14 declared to exist, by reason whereof this act shall take effect and
15 be in full force from and after its passage and approval.
