14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 EDUCATION

16 SECTION 1. There is hereby appropriated to the Oklahoma Arts
17 Council from any monies not otherwise appropriated from the General
18 Revenue Fund of the State Treasury for the fiscal year ending June
19 30, 2011, the sum of _____ Dollars (\$0.00) or so much thereof
20 as may be necessary to perform the duties imposed upon the Oklahoma
21 Arts Council by law.

22 SECTION 2. There is hereby appropriated to the State Board of
23 Career and Technology Education from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2011, the sum of _____ Dollars
2 (\$0.00) or so much thereof as may be necessary to perform the duties
3 imposed upon the State Board of Career and Technology Education by
4 law.

5 SECTION 3. There is hereby appropriated to the State Board of
