12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2011, the sum of
17 _____ Dollars (\$0.00) or so much thereof as may be
18 necessary for allocation by the Oklahoma State Regents for Higher
19 Education pursuant to the provisions of Article XIII-A of the
20 Oklahoma Constitution for the education and general operating
21 budgets of the institutions and for other programs, construction,
22 renovations or repairs administered by the Oklahoma State Regents
23 for Higher Education.

1 SECTION 2. The Oklahoma State Regents for Higher Education are
2 hereby authorized to expend during the fiscal year ending June 30,
3 2011, the sum of _____ Dollars (\$0.00) from the Higher
4 Education Capital Revolving Fund of the State Treasury for
5 allocation by the Oklahoma State Regents for Higher Education
6 pursuant to the provisions of Article XIII-A of the Oklahoma
7 Constitution for the education and general operating budgets of the
8 institutions and for other programs, construction, renovations or
9 repairs administered by the Oklahoma State Regents for Higher
10 Education.

11 SECTION 3. The Oklahoma State Regents for Higher Education are
12 hereby authorized to expend during the fiscal year ending June 30,
13 2011, the sum of _____ Dollars (\$0.00) from the
14 Oklahoma Tuition Scholarship Revolving Fund of the State Treasury
15 for allocation by the Oklahoma State Regents for Higher Education
16 pursuant to the provisions of Article XIII-A of the Oklahoma
17 Constitution for the education and general operating budgets of the
18 institutions and for other programs, construction, renovations or
19 repairs administered by the Oklahoma State Regents for Higher
20 Education.

21 SECTION 4. There is hereby appropriated to the Oklahoma State
22 Regents for Higher Education from any monies not otherwise
23 appropriated from the Special Cash Fund of the State Treasury, the
24 sum of _____ Dollars (\$0.00) or so much thereof as

1 may be necessary for the education and general operating budgets of
2 the institutions and for other programs, construction, renovations
3 or repairs administered by the Oklahoma State Regents for Higher
4 Education.

5 SECTION 5. Appropriations made by this act, not including
6 appropriations made for capital outlay purposes, may be budgeted for
7 the fiscal year ending June 30, 2011 (hereafter FY-11) or may be
8 budgeted for the fiscal year ending June 30, 2012 (hereafter FY-12).
9 Funds budgeted for FY-11 may be encumbered only through June 30,
10 2011, and must be expended by November 15, 2011. Any funds
11 remaining after November 15, 2011, and not budgeted for FY-12, shall
12 lapse to the credit of the proper fund for the then current fiscal
13 year. Funds budgeted for FY-12 may be encumbered only through June
14 30, 2012. Any funds remaining after November 15, 2012, shall lapse
15 to the credit of the proper fund for the then current fiscal year.
16 These appropriations may not be budgeted in both fiscal years
17 simultaneously. Funds budgeted in FY-11, and not required to pay
18 obligations for that fiscal year, may be budgeted for FY-12, after
19 the agency to which the funds have been appropriated has prepared
20 and submitted a budget work program revision removing these funds
21 from the FY-11 budget work program and after such revision has been
22 approved by the Office of State Finance.

23 SECTION 6. This act shall become effective July 1, 2010.

1 SECTION 7. It being immediately necessary for the preservation
2 of the public peace, health and safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
