7 An Act relating to roads, bridges and ferries;
8 designating the Fern Holland Memorial Highway, the
9 Tommy Azlin Memorial Highway, the Joe Hemphill
10 Memorial Bridge, the F.L. Holton Memorial Bridge, the
11 State Representative Tim Pope Memorial Bridge and the
USMC Cpl. Jeremy D. Allbaugh Memorial Highway;
12 providing for placement of permanent markers;
13 providing for codification; and providing an
effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 1698.60 of Title 69, unless
17 there is created a duplication in numbering, reads as follows:

18 That portion of State Highway 25 from the junction of State
19 Highway 25 and U.S. Highway 59 extending west to the Ottawa County
20 line shall be designated as the "Fern Holland Memorial Highway".
21 The Department of Transportation shall cause suitable permanent
22 markers to be placed on the highway bearing that name.

1 SECTION 2. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.61 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 That portion of U.S. Highway 59 South of Heavener from the
5 Poteau River Bridge extending south to the Hodgen city limits shall
6 be designated as the "Tommy Azlin Memorial Highway". The Department
7 of Transportation shall cause suitable permanent markers to be
8 placed on the highway bearing that name.

9 SECTION 3. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.62 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The bridge crossing Polk Creek on the Poteau Bypass shall be
13 designated the "Joe Hemphill Memorial Bridge". The Department of
14 Transportation shall cause suitable permanent markers to be placed
15 on the highway bearing that name.

16 SECTION 4. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.63 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The bridge crossing McMurtry Creek on the Poteau Bypass shall
20 be designated the "F.L. Holton Memorial Bridge". The Department of
21 Transportation shall cause suitable permanent markers to be placed
22 on the highway bearing that name.

1 SECTION 5. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.64 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge on State Highway 4 that crosses the Canadian River
5 between Mustang and Tuttle shall be designated the "State
6 Representative Tim Pope Memorial Bridge". The Department of
7 Transportation shall cause suitable permanent markers to be placed
8 on the bridge bearing that name.

9 SECTION 6. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.65 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The portion of State Highway 11 in Blackwell between Interstate
13 35 and 13th Street shall be designated as the "USMC Cpl. Jeremy D.
14 Allbaugh Memorial Highway". The Department of Transportation shall
15 cause suitable permanent markers to be placed on the bridge bearing
16 that name.

17 SECTION 7. This act shall become effective November 1, 2010.
