14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 47 O.S. 2001, Section 40-122, as
16 amended by Section 2, Chapter 472, O.S.L. 2002 (47 O.S. Supp. 2009,
17 Section 40-122), is amended to read as follows:

18 Section 40-122. A. There is hereby created the Advisory
19 Committee for Motorcycle Safety and Education which shall be
20 comprised of the Administrator, who shall serve as chair of the
21 Committee and shall be a nonvoting member, and seven (7) voting
22 members, six of whom shall be appointed by the Commissioner of
23 Public Safety and one of whom shall be appointed by the Insurance
24 Commissioner. One member shall be a certified instructor of

1 motorcycle safety and education; ~~one member~~ three members shall be a
2 licensed and safety course certified motorcycle ~~operator/owner~~; ~~one~~
3 ~~member shall be an employee of the Department of Public Safety~~; ~~one~~
4 ~~member shall represent the interests of district court and municipal~~
5 ~~judges that hear cases pertaining to traffic laws~~ operators/owners;
6 one member shall represent private sector motorcycle rider education
7 schools; one member shall be a representative of the Oklahoma
8 Highway Safety Office; and the member appointed by the Insurance
9 Commissioner shall be an employee of the Office of the Insurance
10 ~~Commissioner's office~~ Commissioner. Members shall serve at the
11 pleasure of the appointing authority.

12 B. The Committee shall meet at the call of the Administrator or
13 the Commissioner. A vice-chair shall be elected by the Committee
14 from among its members. The vice-chair shall act as chair of the
15 Committee only in the absence of the Administrator at officially
16 called meetings of the Committee.

17 C. The Committee shall advise and assist the Commissioner in
18 the development, administration and operation of the Motorcycle
19 Safety and Education Program and the setting of goals, objectives
20 and priorities for the Program.

21 D. The provisions of this section shall not be construed to
22 authorize the creation of any additional salaried position within
23 the Department of Public Safety.

1 E. Members of the Committee who are not state employees shall
2 receive no compensation from the state for serving on the Committee.
3 All members of the Committee shall be entitled to reimbursement for
4 any actual and necessary traveling expenses pursuant to the State
5 Travel Reimbursement Act.

6 SECTION 2. This act shall become effective November 1, 2010.
