8 A Concurrent Resolution supporting the establishment
9 of an Oklahoma Music Trail; directing certain public
10 entities to cooperate and coordinate the Oklahoma
11 Music Trail; and directing distribution.

12 WHEREAS, the establishment of an Oklahoma Music Trail would be
13 of great benefit to tourism and economic development for or in the
14 State of Oklahoma; and

15 WHEREAS, site locations on the Oklahoma Music Trail would be
16 places of significance with respect to the musical heritage of
17 Oklahoma, including residences, commercial buildings or other
18 structures that highlight the lives, careers and musical
19 achievements of musicians born in the state or who spent a
20 substantial or significant part of their musical career in Oklahoma;
21 and

22 WHEREAS, the Oklahoma Music Hall of Fame and Museum would be the
23 logical entity to provide support for the Oklahoma Music Trail and
24 select and coordinate a coalition of music historians and scholars

1 | who could develop a list of the most notable musical sites that
2 | memorialize an individual, place or event within the state for
3 | inclusion along the Oklahoma Music Trail; and

4 | WHEREAS, the Oklahoma Music Hall of Fame and Museum in
5 | partnership with the Oklahoma Tourism and Recreation Department, the
6 | Oklahoma Historical Society, the Oklahoma Film and Music Commission
7 | and the Department of Transportation could also coordinate, plan,
8 | and provide administrative support for the Oklahoma Music Trail; and

9 | WHEREAS, a detailed "Oklahoma Music Trail" map, brochure and
10 | website could promote the history, heritage, legends, and folklore
11 | that characterize the musical heritage of Oklahoma and dedicated
12 | markers along the Trail would honor the various musical sites
13 | selected for inclusion along the Trail.

14 | NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
15 | OF THE 2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE, THE SENATE
16 | CONCURRING THEREIN:

17 | THAT the Oklahoma Legislature supports the establishment of an
18 | Oklahoma Music Trail.

19 | THAT the Oklahoma Legislature direct the Oklahoma Music Hall of
20 | Fame and Museum, the Oklahoma Tourism and Recreation Department, the
21 | Oklahoma Historical Society, the Oklahoma Film and Music Commission
22 | and the Department of Transportation to cooperate and coordinate
23 | activities in a partnership to establish, maintain, and promote the
24 | Oklahoma Music Trail.
