13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Department of
15 Central Services from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2011, the sum of _____ Dollars
18 (\$0.00) or so much thereof as may be necessary to perform the duties
19 imposed upon the Department of Central Services by law.

20 SECTION 2. The Department of Central Services is authorized to
21 expend an amount not to exceed _____ Dollars
22 (\$0.00) or so much thereof as may be necessary from the Risk
23 Management Fire Protection Revolving Fund created pursuant to
24 Section 85.58D of Title 74 of the Oklahoma Statutes to provide such

1 salaries and administrative expenses as required by the
2 Comprehensive Professional Risk Management Program provided for in
3 Title 74 of the Oklahoma Statutes.

4 SECTION 3. The Department of Central Services is authorized to
5 expend an amount not to exceed _____ Dollars (\$0.00)
6 or so much thereof as may be necessary from the Oklahoma Motor
7 License Agent Indemnity Fund created pursuant to Section 1143.1 of
8 Title 47 of the Oklahoma Statutes to provide such salaries and
9 administrative expenses as required by the Comprehensive
10 Professional Risk Management Program provided for in Section 85.58A
11 of Title 74 of the Oklahoma Statutes.

12 SECTION 4. The Department of Central Services is authorized to
13 expend an amount not to exceed _____ Dollars (\$0.00)
14 or so much thereof as may be necessary from the Oklahoma Motor
15 License Agent Indemnity Fund created pursuant to Section 1143.1 of
16 Title 47 of the Oklahoma Statutes and for coverage of errors and
17 omissions to provide such salaries and administrative expenses as
18 required by the Comprehensive Professional Risk Management Program
19 provided for in Section 85.58A of Title 74 of the Oklahoma Statutes
20 for administration of errors and omissions coverage authorized by
21 Section 85.58H of Title 74 of the Oklahoma Statutes.

22 SECTION 5. For the fiscal year ending June 30, 2011, the
23 Department of Central Services shall budget all funds in the
24 following categories and amounts:

14 SECTION 6. The duties and compensation of employees, not
15 otherwise prescribed by law, necessary to perform the duties imposed
16 upon the Department of Central Services by law shall be set by the
17 Director of the Department of Central Services. The salary of the
18 Director shall not exceed _____ Dollars (\$0.00) per
19 annum, payable monthly for the fiscal year ending June 30, 2011.

20 The Department of Central Services for the fiscal year ending June
21 30, 2011, shall be subject to the following budgetary limitations on
22 full-time-equivalent employees and expenditures excluding
23 expenditures for capital and special projects, except as may be

1 authorized pursuant to the provisions of Section 3603 of Title 74 of
2 the Oklahoma Statutes:
