13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the State Department
15 of Health from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2011, the sum of _____ Dollars (\$0.00) or so
18 much thereof as may be necessary to perform the duties imposed upon
19 the State Department of Health by law.

20 SECTION 2. For the fiscal year ending June 30, 2011, the State
21 Department of Health shall budget all funds in the following
22 categories and amounts:

12 SECTION 3. The duties and compensation of employees, not
13 otherwise prescribed by law, necessary to perform the duties imposed
14 upon the State Department of Health by law shall be set by the State
15 Commissioner of Health. The salary of the Commissioner shall not
16 exceed _____ Dollars (\$0.00) per annum, payable monthly for the
17 fiscal year ending June 30, 2011. The State Department of Health
18 for the fiscal year ending June 30, 2011, shall be subject to the
19 following budgetary limitations on full-time-equivalent employees
20 and expenditures, excluding expenditures for capital and special
21 projects, except as may be authorized pursuant to the provisions of
22 Section 3603 of Title 74 of the Oklahoma Statutes:
