12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SUBCOMMITTEE ON EDUCATION

14 SECTION 1. There is hereby appropriated to the Oklahoma Arts  
15 Council from any monies not otherwise appropriated from the General  
16 Revenue Fund of the State Treasury for the fiscal year ending June  
17 30, 2011, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof  
18 as may be necessary to perform the duties imposed upon the Oklahoma  
19 Arts Council by law.

20 SECTION 2. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 General Revenue Fund of the State Treasury for the fiscal year  
23 ending June 30, 2011, the sum of \_\_\_\_\_ Dollars (\$0.00) or so

20 the fiscal year ending June 30, 2011, the sum of \_\_\_\_\_

22 uniform computer systems development, including computer software  
23 for county government, in accordance with the State Auditor and  
24 Inspector's duties to prescribe accounting procedures and to provide

1 technical assistance to county government. The appropriation made  
2 in this section shall be expended exclusively for the purpose so  
3 stated and shall not be transferable.

4 SECTION 27. There is hereby appropriated to the Office of the  
5 State Bond Advisor from any monies not otherwise appropriated from  
6 the General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2011, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
8 much thereof as may be necessary to perform the duties imposed upon  
9 the Office of the State Bond Advisor by law.

10 SECTION 28. There is hereby appropriated to the Rural Economic  
11 Action Plan Fund of the State Treasury from any monies not otherwise  
12 appropriated from the General Revenue Fund of the State Treasury for  
13 the fiscal year ending June 30, 2011, the sum of \_\_\_\_\_

14 as may be necessary to pay monthly salaries, per diem, and expenses  
15 of the members of the Senate and the salaries of its employees, and  
16 such contingent expenses as may be ordered paid therefrom, including  
17 the preparation and printing of the journals and calendars of the  
18 Senate, and including the preparation and printing of the permanent  
19 journals thereof, in accordance with the following amount herein set  
20 forth:

6 SECTION 55. There is hereby appropriated to the Oklahoma Tax  
7 Commission from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2011, the sum of \_\_\_\_\_ Dollars (\$0.00) or so
