12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3905, as
14 last amended by Section 2, Chapter 24, O.S.L. 2009 (74 O.S. Supp.
15 2009, Section 3905), is amended to read as follows:

16 Section 3905. The following statutory entities and their
17 successors shall be terminated on July 1, ~~2010~~ 2014, and all powers,
18 duties and functions shall be abolished one (1) year thereafter:

19 1. State Board of Licensure for Professional Engineers and Land
20 Surveyors as created by Section 475.3 of Title 59 of the Oklahoma
21 Statutes;

22 2. Oklahoma Accountancy Board as created by Section 15.2 of
23 Title 59 of the Oklahoma Statutes;

1 3. The Board of Governors of the Licensed Architects, Landscape
2 Architects and Registered Interior Designers of Oklahoma as created
3 by Section 46.4 of Title 59 of the Oklahoma Statutes;

4 4. Oklahoma Funeral Board as created by Section 396 of Title 59
5 of the Oklahoma Statutes;

6 5. Long-Term Care Facility Advisory Board as created by Section
7 1-1923 of Title 63 of the Oklahoma Statutes;

8 6. Commission on Marginally Producing Oil and Gas Wells as
9 created by Section 700 of Title 52 of the Oklahoma Statutes; and

10 7. ~~Minority Teacher Recruitment Advisory Committee as created~~
11 ~~by Section 6-129.1 of Title 70 of the Oklahoma Statutes; and~~

23 2. State Board of Osteopathic Examiners as created by Section
24 624 of Title 59 of the Oklahoma Statutes;

1 3. Board of Podiatric Medical Examiners as created by Section
2 137 of Title 59 of the Oklahoma Statutes; and

3 4. Oklahoma State Athletic Commission as created by Section
4 604.1 of Title 3A of the Oklahoma Statutes; and

5 5. Minority Teacher Recruitment Advisory Committee as created
6 by Section 6-129.1 of Title 70 of the Oklahoma Statutes.
