12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. There is hereby appropriated to the Oklahoma State
14 Bureau of Investigation from any monies not otherwise appropriated
15 from the General Revenue Fund of the State Treasury for the fiscal
16 year ending June 30, 2010, the sum of _____ Dollars
17 (\$0.00) or so much thereof as may be necessary to perform the duties
18 imposed upon the Oklahoma State Bureau of Investigation by law.

19 SECTION 2. For the fiscal year ending June 30, 2010, the
20 Oklahoma State Bureau of Investigation shall budget all funds in the
21 following categories and amounts:

7 SECTION 3. The duties and compensation of employees, not
8 otherwise prescribed by law, necessary to perform the duties imposed
9 upon the Oklahoma State Bureau of Investigation by law shall be set
10 by the Director. The salary of the Director shall not exceed
11 _____ Dollars (\$0.00) per annum, payable monthly for the
12 fiscal year ending June 30, 2010. The Oklahoma State Bureau of
13 Investigation for the fiscal year ending June 30, 2010, shall be
14 subject to the following budgetary limitations on full-time-
15 equivalent employees and expenditures excluding expenditures for
16 capital and special projects, except as may be authorized pursuant
17 to the provisions of Section 3603 of Title 74 of the Oklahoma
18 Statutes:
