10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY Section 1 of Enrolled House Joint  
12 Resolution No. 1058 of the 2nd Session of the 51st Oklahoma  
13 Legislature, is amended to read as follows:

14 Section 1. On and after November 1, 2008, the Legislature  
15 hereby authorizes the Department of Human Services to sell the  
16 following described property in whole or in part:

17 Tulsa County

18 A parcel of ground 276 by 440.6 feet same being more  
19 specifically described as follows: Beginning at a point on a  
20 straight line 60 feet East of the Southeast corner of Block 2 in  
21 East Lynn Addition to the City of Tulsa, Oklahoma, as shown by  
22 the recorded plat thereof at the intersection of Quincy Avenue  
23 and Eighth Street; thence running East on a straight line and  
24 along the North boundary line of Eighth Street a distance of 276

1 feet to a point; thence North on a straight line parallel with  
2 the East boundary line of Quincy Avenue, to a point a distance  
3 of 440.6 feet; thence west on a straight line parallel to the  
4 North boundary line of the said Eighth Street to a point on  
5 Quincy Avenue a distance of 276 feet; thence South on a straight  
6 line and along the East boundary of Quincy Avenue a distance of  
7 440.6 feet to the point of beginning.

8 The above tract of land being identical with the tract of land  
9 reserved in the plat and dedication of East Lynn Addition by  
10 Albert A. Small, the plat being dated March 1, 1909, and the  
11 dedication March 6, 1909, wherein the above tract of land was  
12 reserved from East Lynn Addition as being the property of the  
13 allottee and which tract of land is therein described as  
14 follows: That part of Lot 11 in section 6, township 19 north,  
15 range 13 east, beginning 200 feet west of Northeast Corner of  
16 said lot 11 and running thence South 440.6 feet to a point:  
17 thence West 276 feet to a point; thence North 440.6 feet to a  
18 point and thence East 276 feet to place of beginning.

19 Lots 1, 2, 3, 4, 5, 7 and 9 all in the subdivision of Block 11  
20 East Lynn Addition to the City of Tulsa, Tulsa County, Oklahoma,  
21 according to the recorded plat thereof.

22 The sale shall be contingent upon submission of the sale of the  
23 property for public auction or sealed bids by the Department of  
24 Central Services in compliance with Section 129.4 of Title 74 of the
