9 404.3), which relates to liability insurance for
10 child care facilities; clarifying language; modifying
11 required location of certain forms; and providing an
12 effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13

SECTION 1. AMENDATORY Section 2, Chapter 58, O.S.L. 2008

14

(10 O.S. Supp. 2008, Section 404.3), is amended to read as follows:

Section 404.3 A. A child care facility shall maintain

16

liability insurance coverage of at least Two Hundred Thousand

17

Dollars (\$200,000.00) for each occurrence of negligence. An

18

insurance policy or contract required under this section shall cover

19

injury to a child due to negligence that occurs while the child is

20

on the premises of the child care facility or in the care of the

21

child care facility.

B. The ~~Department of~~ Commission for Human Services shall

23

promulgate rules providing for a standard form to be signed and

24

dated by an insurance agent licensed in this state stating that the

1 child care facility has an unexpired and uncanceled insurance
2 policy or contract of at least Two Hundred Thousand Dollars
3 (\$200,000.00) that meets the requirements of this section. This
4 form shall be completed annually and shall be kept in the file of
5 located at the child care facility.

6 C. Should the child care facility for financial reasons or for
7 lack of availability of an underwriter willing to issue a policy be
8 unable to secure the insurance required under subsection A of this
9 section or should the policy limits be exhausted, the child care
10 facility shall notify the parent or guardian of each child for whom
11 the child care facility provides care a written notice that the
12 liability coverage is not provided and there will not be a ground
13 for suspension or revocation of the child care facility's license
14 under the Oklahoma Child Care Facilities Licensing Act. The child
15 care facility shall also notify the Department that coverage is not
16 provided and provide the reason for same.

17 D. The ~~Department~~ Commission shall promulgate rules providing
18 for a standard form for the facility to provide to parents or
19 guardians notifying the parents or guardians that the facility does
20 not carry liability insurance for the reasons allowed in subsection
21 C of this section. This form shall be signed and dated by a parent
22 or guardian and maintained in the file of the child. If the
23 facility is without insurance for reasons provided for in subsection
24 C of this section for longer than one (1) year, the facility shall

1 update this notification form with signatures and dates annually.
2 In no case shall the inability to secure coverage serve to indemnify
3 the child care facility due to negligence.

4 E. The insurance policy or contract shall be maintained at all
5 times in an amount as required by this section, except as provided
6 for in subsections C and D of this section. Failure by a child care
7 facility to renew the policy or contract or to maintain the policy
8 or contract in the required amount is a ground for suspension or
9 revocation of the child care facility license under the Oklahoma
10 Child Care Facilities Licensing Act.

11 F. This section shall not apply to foster family homes or group
12 homes.

13 SECTION 2. This act shall become effective November 1, 2009.
