13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Oklahoma
15 Commission for Teacher Preparation from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2010, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the Oklahoma Commission for Teacher
20 Preparation by law.

21 SECTION 2. For the fiscal year ending June 30, 2010, the
22 Oklahoma Commission for Teacher Preparation shall budget all funds
23 in the following categories and amounts:

4 The Commission shall develop outcome-based performance measures
5 for each budget category.

6 SECTION 3. The duties and compensation of employees, not
7 otherwise prescribed by law, necessary to perform the duties imposed
8 upon the Oklahoma Commission for Teacher Preparation by law shall be
9 set by the Executive Director of the Oklahoma Commission for Teacher
10 Preparation. The salary of the Executive Director shall not exceed
11 _____ Dollars (\$0.00) per annum, payable monthly for the
12 fiscal year ending June 30, 2010. The Oklahoma Commission for
13 Teacher Preparation for the fiscal year ending June 30, 2010, shall
14 be subject to the following budgetary limitations on full-time-
15 equivalent employees and expenditures excluding expenditures for
16 capital and special projects, except as may be authorized pursuant
17 to the provisions of Section 3603 of Title 74 of the Oklahoma
18 Statutes:
