10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 47 O.S. 2001, Section 585, as  
12 amended by Section 5, Chapter 298, O.S.L. 2005 (47 O.S. Supp. 2008,  
13 Section 585), is amended to read as follows:

14 Section 585. A. The Commission may deny any application for  
15 license, or suspend or revoke a license issued, or impose a fine, in  
16 accordance with the provisions of the Administrative Procedures Act,  
17 Section 250 et seq. of Title 75 of the Oklahoma Statutes. If the  
18 applicant or licensee is a used motor vehicle salesperson, the  
19 Commission shall in like manner also notify the person, firm,  
20 association, corporation or trust with whom associated, or in whose  
21 association the applicant or licensee is about to enter. The  
22 Commission shall have the power to compel the production of records  
23 and papers bearing upon the complaints. The Commission shall have  
24 the power to subpoena and bring before it any person in this state,

1 or take testimony of any such person by deposition, with the same  
2 fees and mileage and in the same manner as prescribed by law in  
3 judicial procedure before courts of the state in civil cases. Any  
4 party to the hearing shall have the right to the attendance of  
5 witnesses in his behalf upon designating to the Commission the  
6 person or persons sought to be subpoenaed. If the Commission shall  
7 determine that any licensee is guilty of violation of any of the  
8 provisions of this act, the license of the licensee shall be  
9 suspended or revoked, or a fine imposed as authorized by this act.

10 B. The Commission may assess a fine not to exceed One Hundred  
11 Dollars (\$100.00) against a used motor vehicle dealer who:

12 1. Willfully fails to deliver certificates of title to  
13 purchasers of used motor vehicles within thirty (30) days of the  
14 sale of the vehicles;

15 2. Fails to properly reassign the certificate of title to a  
16 used motor vehicle as required by law upon the sale or transfer of  
17 ownership of the used motor vehicle; ~~or~~

18 3. Sells an extended insurance warranty to a purchaser, but  
19 fails to provide a copy of the warranty to the purchaser or fails to  
20 disclose who the third party insurer will be; or

21 4. Delivers a used motor vehicle to a potential purchaser with  
22 the intent to sell the vehicle, but does not complete the  
23 transaction within fifteen (15) calendar days of the delivery of the  
24 used motor vehicle.

1 C. An appeal from the decision of the Commission to suspend or  
2 revoke a license or to impose a fine shall be taken in accordance  
3 with Article II of the Administrative Procedures Act, Section 308a  
4 et seq. of Title 75 of the Oklahoma Statutes.

5 D. Any applicant or licensee who knowingly or willfully makes  
6 or causes to be made any false statement of a fact required under  
7 the provisions of Section 581 et seq. of this title shall be subject  
8 to an administrative fine not to exceed One Thousand Dollars  
9 (\$1,000.00).

10 SECTION 2. This act shall become effective November 1, 2009.
