8 A Concurrent Resolution congratulating Danny Cahill
9 for winning "The Biggest Loser"; commending his
10 attitude; and directing distribution.

11 WHEREAS, Danny Cahill was overweight from the age of seven until
12 he was 15 years old and a sophomore in high school. That is when he
13 lost 75 pounds over the summer. He became popular, played football
14 and was in a rock and roll band. However, after a few years in
15 college and years of taking care of everyone but himself, he
16 ballooned to nearly 450 pounds; and

17 WHEREAS, Danny Cahill, originally from Midwest City, Oklahoma,
18 was an accomplished musician who played in the Donny Osmond Band.
19 Now married, Danny resides in Broken Arrow, Oklahoma, with his wife,
20 son, and daughter. He coaches his son's football team and is a land
21 surveyor by profession. Danny's weight began to take its toll when
22 he was unable to perform simple tasks such as hanging Christmas
23 lights or activities like camping with his son. He had lost weight
24 once, could he do it again? The answer was shared by an untold

1 number of viewers of NBC's reality television program: "The Biggest
2 Loser"; and

3 WHEREAS, the 40-year-old decided not just to lose weight but to
4 do so on the NBC-TV program "The Biggest Loser" and not just win the
5 competition but be the biggest loser ever. It took a year before
6 Danny Cahill was selected out of 500,000 entrants. Not only did
7 Danny win season eight of the program, but also lost 239 pounds in
8 less than seven months to become the biggest loser ever, slimming
9 down from 430 pounds to 191 pounds, 55.58 percent of his original
10 weight; and

11 WHEREAS, Danny Cahill has since appeared on Good Morning America
12 and the Jay Leno Show. He played exhibition basketball with the
13 Washington Generals, perennial losers who play the Harlem
14 Globetrotters basketball team. His song, "Second Chance" may well
15 thrust him back into the music business. As a motivational speaker,
16 Danny Cahill's message is not to limit yourself, but to set your
17 goals and reach them. You can achieve your dream. His dedication
18 to a healthy mental attitude and physical lifestyle has proven this
19 already.

20 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION
21 OF THE 52ND OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES
