7 A Joint Resolution directing the Secretary of State  
8 to refer to the people for their approval or  
9 rejection a proposed amendment to Sections 11A and  
10 11B of Article V of the Oklahoma Constitution;  
11 changing name of the Apportionment Commission;  
12 modifying membership of the Commission; providing for  
13 chair of Commission; modifying the number of members  
14 of the Commission required to sign certain orders;  
15 providing ballot title; and directing filing.

16  
17 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE  
18 1ST SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

19 SECTION 1. The Secretary of State shall refer to the people for  
20 their approval or rejection, as and in the manner provided by law,  
21 the following proposed amendment to Section 11A of Article V of the  
22 Oklahoma Constitution to read as follows:

23 Section 11A. The apportionment of the Legislature shall be  
24 accomplished by the Legislature according to the provisions of this  
article, within ninety (90) legislative days after the convening of  
the first regular session of the Legislature following each Federal  
Decennial Census. If the Legislature shall fail or refuse to make  
such apportionment within the time provided herein, then such

1 apporportionment shall be accomplished by ~~an Apporportionment~~ the  
2 Bipartisan Commission ~~composed of the Attorney General,~~  
3 ~~Superintendent of Public Instruction and the State Treasurer of the~~  
4 ~~State of Oklahoma~~ on Legislative Apporportionment, according to the  
5 provisions of this article. The Commission shall be composed of  
6 seven (7) members as follows: the Lieutenant Governor, who shall be  
7 nonvoting and the chair of the Commission; two members, one  
8 republican and one democrat, appointed by the President Pro Tempore  
9 of the Senate; two members, one republican and one democrat,  
10 appointed by the Speaker of the House of Representatives; and two  
11 members, one republican and one democrat, appointed by the Governor.

12 SECTION 2. The Secretary of State shall refer to the people for  
13 their approval or rejection, as and in the manner provided by law,  
14 the following proposed amendment to Section 11B of Article V of the  
15 Oklahoma Constitution to read as follows:

16 Section 11B. Each order of apporportionment rendered by the  
17 ~~Apporportionment~~ Bipartisan Commission on Legislative Apporportionment  
18 shall be in writing and shall be filed with the Secretary of State  
19 and shall be signed by at least ~~two~~ four members of the Commission.

20 SECTION 3. The Ballot Title for the proposed Constitutional  
21 amendments as set forth in SECTIONS 1 and 2 of this resolution shall  
22 be in the following form:

1 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

2 This measure amends Sections 11A and 11B of Article 5 of the  
3 State Constitution. The measure would change the name of the  
4 Apportionment Commission. The new name would be the Bipartisan  
5 Commission on Legislative Apportionment. Currently, the members  
6 of the Apportionment Commission are the Attorney General, the  
7 Superintendent of Public Instruction and the State Treasurer.  
8 The membership would be changed to seven members. The voting  
9 members of the Commission would consist of equal numbers of  
10 republicans and democrats. One democrat and one republican  
11 would be appointed by the President Pro Tempore of the Senate.  
12 One democrat and one republican would be appointed by the  
13 Speaker of the House of Representatives. One democrat and one  
14 republican would be appointed by the Governor. The Lieutenant  
15 Governor would be a nonvoting member. The Lieutenant Governor  
16 would serve as chair of the Commission. Currently, at least two  
17 members of the Commission are required to sign orders of  
18 apportionment. The measure would change the number to four  
19 members.
