An Act relating to the Oklahoma State Regents for Higher Education; amending Sections 18 and 19, Chapter 421, O.S.L. 2009, which relate to appropriations and expenditures; modifying expenditure authorizations; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 18, Chapter 421, O.S.L. 2009, is amended to read as follows:

Section 18. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2010, the sum of ~~Thirty-three Million One Hundred Ninety-six Thousand Eight Hundred Ninety-three Dollars (\$33,196,893.00)~~ Forty-five Million Nine Hundred Seventy-six Thousand Eight Hundred Ninety-three Dollars (\$45,976,893.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 2. AMENDATORY Section 19, Chapter 421, O.S.L. 2009, is amended to read as follows:

Section 19. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2010, the sum of ~~Thirty three Million One Hundred Ninety six Thousand Eight Hundred Ninety three Dollars (\$33,196,893.00)~~ Forty-five Million Nine Hundred Seventy-six Thousand Eight Hundred Ninety-three Dollars (\$45,976,893.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 3. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
