An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Commissioners of the Land Office, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma State Regents for Higher Education, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Oklahoma Arts Council, the Oklahoma Educational Television Authority, the Oklahoma Department of Libraries, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission,

the Office of the State Treasurer, the Department of Transportation, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, district attorneys and the District Attorneys Council, the Court of Criminal Appeals, the Supreme Court, the Council on Judicial Complaints, the Workers' Compensation Court, the Oklahoma Indigent Defense System, and the Department of Corrections; stating amounts of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; authorizing and requiring certain transfers;

requiring certain deposit; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Five Hundred Ninety-nine Million Six Hundred Five Thousand One Hundred Eighty-one Dollars (\$599,605,181.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2011, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Million Eighty-five Thousand Dollars (\$4,085,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of One Million Six Hundred Fifty-five Thousand Eight Hundred Seventy-six Dollars (\$1,655,876.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Twenty-seven Million

Six Hundred Ninety-eight Thousand Seven Hundred Thirty Dollars (\$27,698,730.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. The State Board of Education is hereby authorized to expend from the Education Stabilization component of the American Recovery and Reinvestment Act Fund, the sum of One Hundred Thirty-nine Million Five Hundred Twenty-one Thousand Six Hundred Thirty-five Dollars (\$139,521,635.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Education by law.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Hundred Nineteen Million Seven Hundred Eighty-nine Thousand Four Dollars (\$419,789,004.00) or so much thereof as may be necessary for the support of public schools activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Twenty-two Million Three Hundred Forty-two Thousand Six Hundred Ninety-two Dollars (\$22,342,692.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Seventy-seven Thousand Six Hundred Thirty-seven Dollars (\$3,077,637.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Seventy-seven Thousand Six Hundred Thirty-seven Dollars (\$3,077,637.00) or

so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 11. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Seven Million One Hundred Nine Thousand Dollars (\$7,109,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 12. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Six Million Five Hundred Forty Thousand Eighty Dollars (\$6,540,080.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 13. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Million Six Hundred Forty-one Thousand Fifty-three Dollars (\$1,641,053.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 14. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Hundred Thirty-eight Million Five Hundred Ninety-one Thousand Nine Hundred Two Dollars (\$138,591,902.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 15. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Three Hundred Eighty-five Thousand Four Hundred

Dollars (\$3,385,400.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 16. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Seven Hundred Forty-nine Million Six Hundred Thousand Seventy-eight Dollars (\$749,600,078.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Four Million Sixty-five Thousand Eight Hundred Fifty-eight Dollars (\$4,065,858.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 17. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2011, the sum of Forty-eight Million Seven Hundred Sixty-seven Thousand Seven Hundred Five Dollars (\$48,767,705.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 18. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2011, the sum of Forty-eight Million Seven Hundred Sixty-seven Thousand Seven Hundred Five Dollars (\$48,767,705.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education

pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 19. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Sixty-five Million Dollars (\$65,000,000.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 20. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the sum of Four Hundred Thirty-two Dollars (\$432.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 21. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the proceeds of the sale of bonds deposited in the Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the sum of Two Hundred Twenty-six Dollars (\$226.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 22. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise

appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Million Three Hundred Ten Thousand One Hundred Sixty-three Dollars (\$1,310,163.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 23. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Twenty-four Million Three Hundred Thirteen Thousand Three Hundred Thirty Dollars (\$24,313,330.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Five Million Two Hundred Four Thousand Four Hundred Five Dollars (\$5,204,405.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Seven Hundred One Thousand Nine Hundred Eighty-six Dollars (\$701,986.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 26. The Oklahoma State Regents for Higher Education are hereby authorized to expend from the Education Stabilization component of the American Recovery and Reinvestment Act Fund the sum of Fifty-nine Million Seven Hundred Ninety-four Thousand Nine

Hundred Eighty-six Dollars (\$59,794,986.00) or so much thereof as may be necessary for the allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operation budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 27. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Three Hundred Forty Thousand Two Hundred Eighty-seven Dollars (\$3,340,287.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 28. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 29. The Physician Manpower Training Commission is hereby authorized to expend from the American Recovery and Reinvestment Act Fund, the sum of One Million Seventy-two Thousand Eighty Dollars (\$1,072,080.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 30. The Oklahoma Board of Private Vocational Schools is hereby authorized to expend during the fiscal year ending June 30, 2011, from the Oklahoma Board of Private Vocational Schools Revolving Fund of the State Treasury, the sum of One Hundred Sixty-seven Thousand One Hundred Ninety-four Dollars (\$167,194.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SECTION 31. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June

30, 2011, the sum of Four Million Four Hundred Six Thousand Six Hundred Eighty-nine Dollars (\$4,406,689.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 32. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Million Two Hundred Thousand Three Hundred Sixty Dollars (\$4,200,360.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 33. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Six Million Three Hundred Forty-two Thousand Six Hundred Sixteen Dollars (\$6,342,616.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 34. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Nineteen Million One Hundred Fifty-two Thousand Ninety-six Dollars (\$19,152,096.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 35. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Million Eight Hundred Twenty-two Thousand Five Hundred Eighty-seven Dollars (\$4,822,587.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 36. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2011, the sum of Three Hundred Thirty Thousand Eighty-six Dollars (\$330,086.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 37. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Hundred Fifty-five Thousand Five Hundred Fifty-six Dollars (\$155,556.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 38. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Thirteen Million Six Hundred Fifty-seven Thousand Sixty-six Dollars (\$13,657,066.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 39. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 40. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of Six Hundred Sixty Three Thousand One Hundred Ninety-eight Dollars (\$663,198.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 41. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year

ending June 30, 2011, the sum of One Million Five Hundred One Thousand Two Hundred Forty-nine Dollars (\$1,501,249.00) or so much thereof as may be necessary to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 42. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Five Million Four Hundred Eighty-eight Thousand Ninety-four Dollars (\$5,488,094.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 43. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Two Million Five Hundred Fifty-nine Thousand One Hundred Thirty-one Dollars (\$2,559,131.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 44. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Six Hundred Ninety-two Thousand Seven Hundred Forty-four Dollars (\$692,744.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 45. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Five Hundred Forty-five Thousand Eight Hundred Eighty-two Dollars (\$545,882.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 46. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Nine Million Six Hundred Twenty-three Thousand

Fifty-four Dollars (\$9,623,054.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 47. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of Eleven Million Dollars (\$11,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 48. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Two Million One Hundred Twenty-nine Thousand Six Hundred Seventy-one Dollars (\$2,129,671.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 49. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Fifteen Million Three Hundred Forty-one Thousand Seven Hundred Seventy Dollars (\$15,341,770.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the Oklahoma House of Representatives for the fiscal year ending June 30, 2011, shall be approved by the Speaker of the House of Representatives.

SECTION 50. There is hereby appropriated to the Alcoholic Beverage Laws Enforcement Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Three Hundred Seventy-six Thousand Seven Hundred Three Dollars (\$3,376,703.00) or so much thereof as may be necessary to perform the duties imposed upon the Alcoholic Beverage Laws Enforcement Commission by law.

SECTION 114. There is hereby appropriated to the Office of the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Million Nine Hundred Thirty-two Thousand Four Dollars (\$1,932,004.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Fire Marshal by law.

SECTION 115. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Fourteen Million Seven Hundred Sixteen Thousand Three Hundred Twenty-two Dollars (\$14,716,322.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law.

SECTION 116. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2011, the sum of Three Million One Hundred Twenty-six Thousand Seven Hundred Forty-one Dollars (\$3,126,741.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 117. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2009, the sum of Two Hundred Twenty-six Thousand Eight Hundred Fifty-one Dollars (\$226,851.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 118. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Five Hundred Sixty-four Thousand Twenty-six Dollars (\$564,026.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 119. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Million Seven Hundred Ninety-four Thousand One Hundred Sixty-four Dollars (\$4,794,164.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 120. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Five Million Four Hundred Sixty-six Thousand Four Hundred Eighteen Dollars (\$5,466,418.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 121. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Two Million Three Hundred Thirty-four Thousand One Hundred Sixty-two Dollars (\$2,334,162.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 122. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Eighty-eight Million Four Hundred Thirty-two Thousand Seventy-three Dollars (\$88,432,073.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law. Of the net revenue received by the Department of Public Safety from electronic ticketing, One

Hundred Percent (100%) shall be deposited in the General Revenue Fund for the fiscal year ending June 30, 2011.

SECTION 123. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Eleven Million Nine Hundred Four Thousand Five Hundred Fifty-two Dollars (\$11,904,552.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 124. For the fiscal year ending June 30, 2011, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma Statutes to the Office of the Attorney General's Revolving Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 125. There is hereby appropriated to the District Attorneys Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Thirty-four Million Two Hundred Fifty-seven Thousand Five Hundred Sixty Dollars (\$34,257,560.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the District Attorneys Council shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 126. For the fiscal year ending June 30, 2011, the District Attorneys Council is authorized to transfer an amount not to exceed One Million Dollars (\$1,000,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual

Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 127. For the fiscal year ending June 30, 2011, up to Seven Hundred Seventy-five Thousand Dollars (\$775,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council to support the Crime Victims Compensation Board.

SECTION 128. For the fiscal year ending June 30, 2011, up to One Million Five Hundred One Thousand Three Hundred Seventy-five Dollars (\$1,501,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 129. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Million Two Hundred Ninety-five Thousand Five Hundred Seventy-five Dollars (\$3,295,575.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 130. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Fourteen Million Four Hundred Forty-eight Thousand Six Hundred Thirty-one Dollars (\$14,448,631.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 131. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Nine Hundred Thirty-two Thousand Seven Hundred Twenty-seven Dollars (\$932,727.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 132. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2011, from the State Judicial Revolving Fund of the State Treasury, the sum of Forty Million Eight Hundred Thousand Dollars (\$40,800,000.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 133. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Six Million Eight Hundred Forty-one Thousand Eight Hundred Sixty-five Dollars (\$6,841,865.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 134. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Two Hundred Thirty Thousand Five Hundred Eighty-one Dollars (\$230,581.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 135. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Four Million Three Hundred Forty-nine Thousand Three Hundred Ninety-five Dollars (\$4,349,395.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 136. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Fifteen Million Fifty-three Thousand Nine Hundred Seventy-one Dollars (\$15,053,971.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 137. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirty Million Dollars (\$30,000,000.00) or so much thereof as may be necessary to

perform the duties imposed upon the Department of Corrections by law.

SECTION 138. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of Three Hundred Eighty-two Million One Hundred Forty-one Thousand Seven Hundred Seventy-seven Dollars (\$382,141,777.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 139. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of One Billion Seventy-four Million Three Hundred Thirty Thousand Four Hundred Ninety-five Dollars (\$1,074,330,495.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 140. This act shall become effective July 1, 2010.
