WHEREAS, the National Baptist Convention, USA, Inc., is the largest African-American religious organization in the United States with a membership of over 7.5 million Christians; and

WHEREAS, Dr. Julius R. Scruggs, Pastor of the First Missionary Baptist Church in Huntsville, Alabama, was elected the 17th President of the National Baptist Convention, USA, Inc., in September 2009; and
