A Resolution supporting the establishment of an
Oklahoma Music Trail; encouraging cooperation and
coordination; and directing distribution.

WHEREAS, the establishment of an Oklahoma Music Trail would be
of great benefit to tourism and economic development in the State of
Oklahoma. A distinguished coalition of music historians and
scholars could develop an inventory of the most notable musical
sites within the state to comprise such a Trail; and

WHEREAS, the specific site locations would highlight the lives,
careers and musical achievements of musicians born in the state or
who spent a substantial or significant part of their musical career

in Oklahoma. The sites would be places of significance with respect to Oklahoma's musical heritage, including, but not limited to, residences, commercial buildings or other structures; and

WHEREAS, the Oklahoma Music Hall of Fame and Museum would be the logical entity to approve the memorializing of an individual, place, or event selected for inclusion along the Trail. They would also be the leading candidate to coordinate, plan, and provide administrative support for the Oklahoma Music Trail; and

WHEREAS, a detailed "Oklahoma Music Trail" map and brochure could promote the history, heritage, legends and folklore that characterize Oklahoma's musical heritage. A website and dedicated markers along the Oklahoma Music Trail would honor the various musical artists selected for inclusion along the Trail.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

THAT the Oklahoma State Senate supports the establishment of an Oklahoma Music Trail.

THAT the Oklahoma State Senate encourages all pertinent Oklahoma public entities to cooperate and coordinate their activities in a partnership to establish, maintain, and promote the Oklahoma Music Trail.

THAT a copy of this resolution be distributed to the Oklahoma Music Hall of Fame and Museum, the Oklahoma Tourism and Recreation Department, the Oklahoma Historical Society, the Oklahoma Film and Music Commission, and the Oklahoma Department of Transportation.
