10 An Act relating to roads, bridges and ferries;  
11 designating the State Representative Terry Hyman  
12 Memorial Highway; providing for placement of  
13 permanent markers; designating the Carsyn Kay Hackler  
14 Memorial Highway; providing for placement of  
15 permanent markers; designating the M/SGT Ura M.  
16 Horton Memorial Bridge; providing for placement of  
17 permanent markers; designating the TSGT Jason Norton  
18 Memorial Bridge; providing for placement of permanent  
19 markers; designating the Commissioner Jimmie Primrose  
20 Memorial Bridge; providing for placement of permanent  
21 markers; designating the SSGT Larry S. Pierce  
22 Memorial Highway; providing for permanent markers;  
23 designating the Sheriff Jerry Beall and Police Chief  
24 Joe Rowden Memorial Highway; providing for permanent  
markers; designating the Mazzebeth Turner Memorial  
Highway; providing for permanent markers; designating  
the U.S. Army 509th Engineer Company Memorial Bridge;  
providing for permanent markers; providing for  
codification; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.43 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 32 from Interstate 35 west to the  
5 Jefferson County Line shall be designated as the "State  
6 Representative Terry Hyman Memorial Highway". The Department of  
7 Transportation shall cause suitable permanent markers to be placed  
8 on the highway bearing that name.

9 SECTION 2. NEW LAW A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.44 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12 The portion of State Highway 63 from Kiowa, Oklahoma, extending  
13 east approximately three (3) miles to Pittsburg, Oklahoma, shall be  
14 designated as the "Carsyn Kay Hackler Memorial Highway". The  
15 Department of Transportation shall cause suitable permanent markers  
16 to be placed on the highway bearing that name.

17 SECTION 3. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 1698.45 of Title 69, unless  
19 there is created a duplication in numbering, reads as follows:

20 The bridge in Pontotoc County on State Highway 48 approximately  
21 five (5) miles south of Allen, Oklahoma, shall be designated as the  
22 "M/SGT Ura M. Horton Memorial Bridge". The Department of  
23 Transportation shall cause suitable permanent markers to be placed  
24 on the bridge bearing that name.

1 SECTION 4. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.46 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4 The bridge that crosses the Neosho River on State Highway 125 at  
5 Riverview Park in Miami, Oklahoma, shall be designated the "TSGT  
6 Jason Norton Memorial Bridge". The Department of Transportation  
7 shall cause suitable permanent markers to be placed on the bridge  
8 bearing that name.

9 SECTION 5. NEW LAW A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.47 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12 The bridge in Murray County that crosses the Washita River on  
13 State Highway 7 between Interstate 35 and Davis, Oklahoma, shall be  
14 designated the "Commissioner Jimmie Primrose Memorial Bridge". The  
15 Department of Transportation shall cause suitable permanent markers  
16 to be placed on the bridge bearing that name.

17 SECTION 6. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 1698.48 of Title 69, unless  
19 there is created a duplication in numbering, reads as follows:

20 The portion of U.S. Highway 270 between Seminole, Oklahoma, and  
21 Wewoka, Oklahoma, shall be designated as the "SSGT Larry S. Pierce  
22 Memorial Highway". The Department of Transportation shall cause  
23 suitable permanent markers to be placed on the highway bearing that  
24 name.

1 SECTION 7. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.49 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 51 in Payne County that is between  
5 the junctions of State Highway 108 with State Highway 51 shall be  
6 designated as the "Sheriff Jerry Beall and Police Chief Joe Rowden  
7 Memorial Highway". The Department of Transportation shall cause  
8 suitable permanent markers to be placed on the highway bearing that  
9 name.

10 SECTION 8. NEW LAW A new section of law to be codified  
11 in the Oklahoma Statutes as Section 1698.50 of Title 69, unless  
12 there is created a duplication in numbering, reads as follows:

13 The portion of State Highway 77 in Murray County that is between  
14 the junctions of State Highway 77 and Interstate 35 at exits 51 and  
15 47 shall be designated as the "Mazzebeth Turner Memorial Highway".  
16 The Department of Transportation shall cause suitable permanent  
17 markers to be placed on the highway bearing that name.

18 SECTION 9. NEW LAW A new section of law to be codified  
19 in the Oklahoma Statutes as Section 1698.51 of Title 69, unless  
20 there is created a duplication in numbering, reads as follows:

21 The bridge in Oklahoma County on State Highway 4 approximately  
22 one (1) mile north of the junction of State Highway 4 with State  
23 Highway 3 shall be designated as the "U.S. Army 509th Engineer  
24 Company Memorial Bridge". The Department of Transportation shall

1 cause suitable permanent markers to be placed on the highway bearing  
2 that name.

3 SECTION 10. It being immediately necessary for the preservation  
4 of the public peace, health and safety, an emergency is hereby  
5 declared to exist, by reason whereof this act shall take effect and  
6 be in full force from and after its passage and approval.
