House Bill No. 1023

HOUSE BILL NO. 1023 - By: WRIGHT (JOHN) of the House.

An Act relating to sunset; amending 74 O.S. 2001, Section 3904, as amended by Section 1, Chapter 26, O.S.L. 2003 (74 O.S. Supp. 2008, Section 3904), which relates to the termination of certain statutory entities; re-creating certain entities; modifying list of statutory entities subject to re-creation; and modifying termination date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3904, as amended by
2 Section 1, Chapter 26, O.S.L. 2003 (74 O.S. Supp. 2008, Section 3904), is amended to
3 read as follows:

4 Section 3904. The following statutory entities and their successors shall be
5 terminated on ~~July 1, 2009~~ _____, and all powers, duties and
6 functions shall be abolished one (1) year thereafter:

7 1. State Board of Cosmetology as created by Section 199.2 of Title 59 of the
8 Oklahoma Statutes;

9 2. State Barber Advisory Board as created by Section 61.4 of Title 59 of the
10 Oklahoma Statutes;

11 3. Oklahoma Real Estate Commission as created by Section 858-201 of Title 59 of
12 the Oklahoma Statutes;

- 1 4. State Board of Examiners of Psychologists as created by Section 1354 of Title 59
2 of the Oklahoma Statutes;
- 3 5. Scenic ~~River~~ Rivers Commission as created by Section 1461 of Title 82 of the
4 Oklahoma Statutes;
- 5 6. Domestic Violence and Sexual Assault Advisory ~~Committee~~ Council as created by
6 Section ~~3-312~~ 18p-2 of Title ~~43A~~ 74 of the Oklahoma Statutes;
- 7 7. State Board of Medical Licensure and Supervision as created by Section 481 of
8 Title 59 of the Oklahoma Statutes;
- 9 8. Group Homes for Persons with Developmental or Physical Disabilities Advisory
10 Board as created by Section 1430.4 of Title 10 of the Oklahoma Statutes; and
