House Bill No. 2282

HOUSE BILL NO. 2282 - By: WRIGHT (JOHN) of the House and ALDRIDGE of the Senate.

An Act relating to sunset; amending 10 O.S. 2001, Section 1430.4, as last amended by Section 1, Chapter 22, O.S.L. 2009 (10 O.S. Supp. 2009, Section 1430.4), which relates to the Group Homes for Persons with Developmental or Physical Disabilities Advisory Board; re-creating the Board; and modifying termination date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 10 O.S. 2001, Section 1430.4, as last amended by
2 Section 1, Chapter 22, O.S.L. 2009 (10 O.S. Supp. 2009, Section 1430.4), is amended to
3 read as follows:

4 Section 1430.4 A. There is hereby re-created to continue until July 1, ~~2010~~ 2014, in
5 accordance with the provisions of the Oklahoma Sunset Law, the Group Homes for
6 Persons with Developmental or Physical Disabilities Advisory Board.

7 1. The Advisory Board shall be composed of nine (9) members as follows:

8 a. eight members, appointed by the Director of Human Services, one of
9 whom shall be a representative of the Oklahoma Community Based
10 Providers Association, one a representative of United Cerebral Palsy of
11 Oklahoma, one a representative of the State Council on Developmental
12 Disabilities who is not a state employee, two who shall be group home

1 directors having a minimum of two (2) years of experience as a group
2 home director, and three who shall be consumers or consumer
3 advocates, one of whom is the parent of a person having a
4 developmental disability. These appointed members shall each serve a
5 three-year term and may be reappointed, and

6 b. one member shall be the State Fire Marshal, or a designee who shall
7 serve at the pleasure of the State Fire Marshal.

8 2. The Advisory Board shall annually elect a chair, a vice-chair and a secretary and
9 shall meet at least quarterly and at such other times as may be necessary. All meetings
10 of the Advisory Board shall be subject to the provisions of the Oklahoma Open Meeting
11 Act. Members of the Advisory Board shall not receive compensation for their services but
12 shall be reimbursed pursuant to the provisions of the State Travel Reimbursement Act;
13 and

14 3. The Department of Human Services shall appoint an employee to serve as a
15 resource person and provide assistance to the Advisory Board.

16 B. The Advisory Board shall have the power and duty to:

17 1. Serve as an advisory body to the Department for the development and
18 improvement of services to and care and treatment of residents of group homes subject to
19 the provisions of the Group Homes for Persons with Developmental or Physical
20 Disabilities Act;

21 2. Review, make recommendations regarding, and approve in its advisory capacity
22 the system of standards developed by the Department;

1 3. Evaluate and review the standards, practices, and procedures of the Department
2 regarding the administration and enforcement of the provisions of the Group Homes for
3 Persons with Developmental or Physical Disabilities Act and the quality of services and
4 care and treatment provided to residents of group homes, and may make
5 recommendations to the Department as necessary and appropriate; and

6 4. Serve as an advisory body to the Department regarding the implementation of
7 any nationally recognized accreditation standards, as they apply to community-based
8 facilities and services adopted by the Commission for Human Services as standards for
9 the provision of services to persons with developmental or physical disabilities who
10 receive services through the Department of Human Services.

11 C. The Department shall, with regard to the meetings and duties of the Advisory
12 Board which pertain to the Department, provide clerical staff support to assist the
13 Advisory Board and space for meetings.
