HOUSE BILL NO. 2366 - By: MILLER AND MARTIN (SCOTT) of the House and JOHNSON (MIKE) AND MYERS of the Senate.

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Career and Technology Education, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund of the State Treasury, the Office of the State Bond Advisor, the Department of Central Services, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission, the Department of Transportation, the Office of the State Treasurer, the Oklahoma Health Care Authority, the State Department of Health, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Alcoholic Beverage Laws Enforcement Commission, the Office of the Attorney General, the Department of Corrections, the Court of Criminal Appeals, the District Attorneys Council,

the State Fire Marshal, the Oklahoma Indigent Defense System, the Oklahoma State Bureau of Investigation, the Council on Judicial Complaints, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Supreme Court, the Workers' Compensation Court, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the State Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Oklahoma Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board and the Will Rogers Memorial Commission; stating amounts of appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

1 SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any
2 monies not otherwise appropriated from the General Revenue Fund of the State
3 Treasury for the fiscal year ending June 30, 2011, the sum of _____ Dollars (\$0.00)
4 or so much thereof as may be necessary to perform the duties imposed upon the
5 Oklahoma Arts Council by law.

6 SECTION 2. There is hereby appropriated to the State Board of Career and
7 Technology Education from any monies not otherwise appropriated from the General
8 Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of

1 _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties
2 imposed upon the State Board of Career and Technology Education by law.

3 SECTION 3. There is hereby appropriated to the State Board of Career and
4 Technology Education from monies not otherwise appropriated from the General
5 Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of
6 _____ Dollars (\$0.00) or so much thereof as may be necessary for the Certified
7 Employee Health Benefit Allowance.

8 SECTION 4. There is hereby appropriated to the State Board of Career and
9 Technology Education from monies not otherwise appropriated from the General
10 Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of
11 _____ Dollars (\$0.00) or so much thereof as may be necessary for the Support
12 Personnel Health Benefit Allowance.

13 SECTION 5. There is hereby appropriated to the State Board of Education from
14 any monies not otherwise appropriated from the General Revenue Fund of the State
15 Treasury for the fiscal year ending June 30, 2011, the sum of _____ Dollars (\$0.00)
16 or so much thereof as may be necessary for the financial support of public schools.

17 SECTION 6. The State Board of Education is hereby authorized to expend during
18 the fiscal year ending June 30, 2011, from the Education Reform Revolving Fund created
19 in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of _____ Dollars
20 (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

21 SECTION 7. There is hereby appropriated to the State Board of Education from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending

1 June 30, 2011, the sum of _____ Dollars (\$0.00) or so much thereof as may be
2 necessary for the financial support of public schools.

3 SECTION 8. There is hereby appropriated to the State Board of Education from
4 any monies not otherwise appropriated from the Mineral Leasing Fund of the State
5 Treasury for the fiscal year ending June 30, 2011, the sum of _____ Dollars (\$0.00)
6 or so much thereof as may be necessary for the financial support of public schools.

7 SECTION 9. There is hereby appropriated to the State Board of Education from
8 any monies not otherwise appropriated from the Mineral Leasing Fund of the State
9 Treasury for the fiscal year ending June 30, 2009, the sum of _____ Dollars (\$0.00)
10 or so much thereof as may be necessary for the financial support of public schools.

11 SECTION 10. The State Board of Education is hereby authorized to expend during
12 the fiscal year ending June 30, 2011, from the Common Education Technology Revolving
13 Fund of the State Treasury, the sum of _____ Dollars (\$0.00) or so much thereof as
14 may be necessary for the financial support of public schools.

15 SECTION 11. There is hereby appropriated to the State Board of Education from
16 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust
17 Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary for transfer to the School
19 Consolidation Assistance Fund.

20 SECTION 12. There is hereby appropriated to the State Board of Education from
21 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust
22 Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of

2 repairs administered by the Oklahoma State Regents for Higher Education.

3 SECTION 21. The Oklahoma State Regents for Higher Education are hereby

6 Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to

9 renovations or repairs administered by the Oklahoma State Regents for Higher
10 Education.

11 SECTION 22. There is hereby appropriated to the Oklahoma State Regents for
12 Higher Education from any monies not otherwise appropriated from the Oklahoma
13 Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30,
14 2011, the sum of _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C of
15 Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State
16 Regents for Higher Education pursuant to the provisions of Article XIII-A of the
17 Oklahoma Constitution for the education and general operating budgets of the
18 institutions and for other programs, construction, renovations or repairs administered by
19 the Oklahoma State Regents for Higher Education.

20 SECTION 23. There is hereby appropriated to the Oklahoma State Regents for
21 Higher Education from any monies not otherwise appropriated from the General
22 Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of

1 _____ Dollars (\$0.00) or so much thereof as may be necessary for the general
2 operating budget of the Administrative Offices of the Oklahoma State Regents for Higher

16 SECTION 26. There is hereby appropriated to the Oklahoma State Regents for
17 Higher Education from any monies not otherwise appropriated from the General
18 Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of
19 _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties
20 imposed upon the Office of Accountability by law.

21 SECTION 27. There is hereby appropriated to the Commissioners of the Land
