COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 2967 - By: SHANNON of the House.

An Act relating to motor vehicles; amending 47 O.S. 2001, Section 14-111, as amended by Section 7, Chapter 522, O.S.L. 2004 (47 O.S. Supp. 2009, Section 14-111), which relates to transporting merchandise for hire; modifying required documentation; defining term; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 47 O.S. 2001, Section 14-111, as amended by
2 Section 7, Chapter 522, O.S.L. 2004 (47 O.S. Supp. 2009, Section 14-111), is amended to
3 read as follows:
4 Section 14-111. A. Any officer of the Department of Public Safety, the Corporation
5 Commission, any sheriff, or any salaried deputy sheriff is authorized to stop any vehicle
6 upon any road or highway in order to weigh such vehicle by means of portable or
7 stationary scales, or cause the same to be weighed by any official weigher, or upon any
8 privately owned scales and may require that such vehicles be driven to the nearest or
9 most convenient available scales for the purpose of weighing. In the event that any axle
10 weight or the gross weight of any such vehicle be found to exceed the maximum weight
11 authorized by law, or by permit issued therefor, the officer may require, in the case of

1 separable loads, the driver, operator or owner thereof to unload at the site such portion of
2 the load as may be necessary to decrease the weight of such vehicle to the maximum
3 weight authorized by law. Provided, however, that if such load consists of livestock,
4 perishable merchandise, or merchandise that may be destroyed by the weather, then the
5 driver shall be permitted to proceed to the nearest practical unloading point in the
6 direction of destination before discharging such excess cargo. All material so unloaded
7 shall be cared for by the owner or operator of such vehicle at the risk of such owner or
8 operator.

9 B. The operator of any truck or other vehicle transporting farm products for hire or
10 other merchandise for hire shall have in his or her possession a certificate carrying the
11 following information: name of the operator; driver license number; vehicle registration
12 number; Corporation Commission permit number; and statement of owner authorizing
13 transportation of the products by above named operator; ~~and signature of the owner.~~ For
14 the purposes of this section "certificate" includes electronic manifests and other similar
15 documents that include all of the information required pursuant to this section.

16 Should the vehicle be loaded with livestock, the certificate shall include the number
17 of animals, and should the livestock be the property of more than one person, a certificate
18 signed by each owner carrying the above information including the number of animals
19 owned by each owner shall be carried by the operator. Should the operator be the owner
20 of the merchandise or livestock, the merchandise or livestock having just been
21 purchased, the operator shall have in his or her possession a bill of sale for such
22 merchandise or livestock. Should the operator be the owner of livestock or other farm

1 products produced by the operator, the operator shall be required to show satisfactory
2 identification and ownership of the vehicle. Any officer as outlined in this chapter shall
3 have the authority to stop any vehicle loaded with livestock, merchandise or other farm
4 products and investigate as to the ownership of the merchandise, livestock or other farm
5 products. Should the operator of any vehicle be unable to establish to the satisfaction of
6 the officer the ownership of the merchandise, livestock or other products, or shall not
7 have the certificate ~~signed by the owner~~ as specified in this section for the transportation
8 of such merchandise, livestock or other farm products, the merchandise, livestock or
9 other farm products and the vehicle in which they are being transported shall be
10 impounded by the officer and any expense as to the care of any livestock shall be the
11 responsibility of the owner or operator of the vehicle, and any loss or damage of the
12 merchandise, livestock or other farm products shall be the responsibility of the operator
13 or owner, or both.

14 SECTION 2. This act shall become effective July 1, 2010.
