House Resolution No. 1074

HOUSE RESOLUTION NO. 1074 - By: ARMES of the House.

A Resolution relating to agriculture; extending appreciation to the agriculture industry of Oklahoma for efforts and contributions to this state; proclaiming March 25, 2010, as Agriculture Day at the State Capitol; and providing for distribution.

1 WHEREAS, the agriculture industry in Oklahoma is a vital part of Oklahoma's  
2 economy and employs hundreds of thousands of Oklahomans; and

3 WHEREAS, the market value of agricultural production in Oklahoma was  
4 approximately Five Billion Eight Hundred Six Million Sixty-one Thousand Dollars  
5 (\$5,806,061,000.00) in 2007; and

6 WHEREAS, the market value of agricultural machinery and equipment in  
7 Oklahoma was approximately Five Billion Five Hundred Eight Million Forty-eight  
8 Thousand Dollars (\$5,508,048,000.00) in 2007; and

9 WHEREAS, there are approximately eighty-six thousand six hundred farms in  
10 Oklahoma with a total amount of farmland estimated to be over thirty-five million acres;  
11 and

12 WHEREAS, Oklahoma ranked in the top ten nationally for sales of cattle, swine,  
13 and horses, and sales of poultry and eggs were over Seven Hundred Forty-eight Million  
14 Dollars (\$748,000,000.00) in 2007; and

1           WHEREAS, Oklahoma ranks in the top five nationally for the number of acres of  
2 wheat, sorghum, and hay; and

3           WHEREAS, the diversity of the agriculture industry in Oklahoma is evident as  
4 grapes and organic specialty crops have become viable economic alternatives to  
5 traditional crops; and

6           WHEREAS, the future of the agriculture industry requires a dynamic vision as it  
7 faces rapidly evolving technologies and shifting consumer demands; and

8           WHEREAS, the role of the agriculture industry is ever increasing in the areas of  
9 production capacity and environmental protection.

10           NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
11 REPRESENTATIVES OF THE 2ND SESSION OF THE 52ND OKLAHOMA  
12 LEGISLATURE:

13           THAT the Oklahoma House of Representatives extends its sincere appreciation to  
14 Oklahoma’s agriculture industry for its efforts and contributions to this state.

15           THAT the Oklahoma House of Representatives hereby proclaims March 25, 2010,  
16 as “Agriculture Day” at the State Capitol.

17           THAT a copy of this resolution be distributed to the Governor of the State of  
18 Oklahoma and the State Board of Agriculture.
