House Resolution No. 1086

HOUSE RESOLUTION NO. 1086 - By: NATIONS, MARTIN (SCOTT) AND COLLINS of the House.

A Resolution commending the University of Oklahoma Women's Basketball Team; and directing distribution.

1 WHEREAS, OU Women's basketball was the first team in the state's history to
2 appear in consecutive Final Fours in present tournament format; and

3 WHEREAS, OU Women's basketball became one of just eight programs in women's
4 college basketball history to advance to consecutive Final Four appearances; and

5 WHEREAS, OU Women's basketball played the nation's toughest schedule, meeting
6 22 ranked teams through the course of the season, including all four No. 1 seeds of the
7 NCAA Championship; and

8 WHEREAS, OU Women's basketball earned its seventh All-America selection as
9 junior Danielle Robinson was voted to both the coaches' and media's top teams; and

10 WHEREAS, OU Women's basketball had three representatives on the All-Big 12
11 Conference team as Danielle Robinson and Amanda Thompson were voted to the first
12 team and Nyeshia Stevenson to the second team; and

1 WHEREAS, OU Women's basketball had three representatives on the Academic
2 All-Big 12 Conference team with Jasmine Hartman, Danielle Robinson and Amanda
3 Thompson; and

4 WHEREAS, OU Women's basketball carried a cumulative team GPA of 3.15; and

5 WHEREAS, OU Women's basketball achieved an average home attendance that
6 ranked among the top eight nationally for the fifth consecutive year; and

7 WHEREAS, OU Women's basketball finished the season with 27 wins, the sixth
8 most in the program's history; and

9 WHEREAS, OU Women's basketball has, under the coaching of Sherri Coale and
10 through its outstanding performance, become a source of pride for the State of
11 Oklahoma; and

12 WHEREAS, the Oklahoma House of Representatives of the 52nd Legislature takes
13 pride in recognizing the OU Women's Basketball Team.

14 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
15 REPRESENTATIVES OF THE 2ND SESSION OF THE 52ND OKLAHOMA
16 LEGISLATURE:

17 THAT sincere commendation and congratulations is hereby extended to the
