COMMITTEE SUBSTITUTE FOR ENGROSSED SENATE BILL NO. 2318 - By:  
JOLLEY AND PADDACK of the Senate and JONES of the House.

An Act relating to schools; amending 70 O.S. 2001, Section 1210.507, as last amended by Section 3, Chapter 289, O.S.L. 2006 (70 O.S. Supp. 2009, Section 1210.507), which relates to the Oklahoma School Testing Program Act; providing for testing of students enrolled in certain online courses or programs at certain alternative testing locations; specifying certain alternative testing location sites; making alternative testing locations subject to certain rules; making certain school districts or charter school responsible for certain costs; requiring alternative testing locations to be at geographically dispersed sites; allowing additional alternative testing locations; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 70 O.S. 2001, Section 1210.507, as last amended  
2 by Section 3, Chapter 289, O.S.L. 2006 (70 O.S. Supp. 2009, Section 1210.507), is  
3 amended to read as follows:

4 Section 1210.507 A. The State Board of Education shall promulgate rules  
5 necessary for the implementation and administration of the provisions of the Oklahoma  
6 School Testing Program Act.

1 B. The State Board of Education shall require school district boards of education to  
2 annually provide information to the district's students, parents of students, and the  
3 public at large about the proper meaning and use of tests administered pursuant to the  
4 provisions of the Oklahoma School Testing Program Act. The Department shall develop  
5 materials and make them available to school districts regarding the Oklahoma School  
6 Testing Program.

7 C. Students enrolled in an online course or program that is offered by a school  
8 district or charter school that is not the district of residence or is not located in the  
9 district of residence of the student shall be provided the opportunity to take any test  
10 required pursuant to the Oklahoma School Testing Program Act or any other test  
11 generally required of students by the school district in which the student is enrolled at an  
12 alternative testing location approved by the State Board of Education. The alternative  
13 testing locations may be at sites that are not in the school district that is offering the  
14 online course or program or the district of residence. Alternative testing locations may  
15 include technology center school sites or any other testing location selected by the school  
16 district or charter school offering the online course or program. All alternative testing  
17 locations shall be subject to testing location rules promulgated by the State Board of  
18 Education. The school district or charter school offering the online course or program  
19 shall be responsible for any cost incurred in providing an alternative testing location and  
20 any additional cost of administering a test at an alternative testing location. In order to  
21 provide alternative testing locations at geographically dispersed sites, the school district  
22 or charter school offering the online course or program shall, at a minimum, provide not

1 less than six alternative testing locations, with at least one location in each quadrant of  
2 the state and in each of the two metropolitan areas in the state. Additional alternative  
3 testing locations may be provided by the school district or charter school offering the  
4 online course or program.

5 D. The State Board of Education shall seek to establish and post on the Internet a  
6 sample test item bank that will be made available to teachers and will allow them to  
7 create and deliver classroom assessments throughout the school year to check for student  
8 mastery of key concepts assessed by the criterion-referenced tests administered to  
9 students pursuant to the Oklahoma School Testing Program Act. Subject to the  
10 availability of funds, the Board shall annually release end-of-instruction test items and  
11 make them available to the public.

12 ~~D.~~ E. The State Board of Education shall post on the Internet criterion-referenced  
13 sample tests for each grade level and subject matter test administered to students  
14 pursuant to the Oklahoma School Testing Program Act for the purpose of communicating  
15 expectation concerning test difficulty level and format to teacher, parents and students.  
16 The Board shall maintain the sample tests on the Internet throughout the year and, as  
17 changes are made in the state academic content standards, known as the Priority  
18 Academic Student Skills Curriculum, the Board shall update the sample tests. The  
19 Board shall seek to expand the number of sample test items each year and to revise test  
20 items as needed. The sample tests shall reflect the actual test administered to students  
21 and may contain questions used on actual tests given in previous years.

1           E. F. The State Board of Education shall seek to implement an electronic delivery  
2 system for all tests administered pursuant to the Oklahoma School Testing Program Act  
3 that will allow students to participate in computer-based assessments in order to  
4 expedite the delivery and use of the test results.

5           SECTION 2. This act shall become effective November 1, 2010.
