COMMITTEE SUBSTITUTE FOR ENGROSSED SENATE BILL NO. 643 - By: COFFEE
of the Senate and BENGE of the House.

An Act relating to the State Capitol Building; amending 73 O.S. 2001, Section 15.1, as amended by Section 1, Chapter 89, O.S.L. 2006 (73 O.S. Supp. 2008, Section 15.1), which relates to management and control of space by the Legislature; modifying space under such management and control; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

- 1 SECTION 1. AMENDATORY 73 O.S. 2001, Section 15.1, as amended by
2 Section 1, Chapter 89, O.S.L. 2006 (73 O.S. Supp. 2008, Section 15.1), is amended to read
3 as follows:
4 Section 15.1 A. The Legislature shall have management and control of the
5 following space in the State Capitol Building:
6 1. The space on the third, fourth, fifth and sixth floors;
7 2. The space in the basement that is occupied by the Legislature on June 1, 1995;
8 3. Approximately six thousand nine hundred thirty-nine (6,939) square feet of
9 space in the west wing of the first floor that is occupied by the Department of Libraries
10 on June 1, 1995;

1 4. Approximately six thousand six hundred ninety-one (6,691) square feet of space
2 in the west wing of the basement that is occupied by the Department of Libraries and the
3 Department of Central Services on June 1, 1995;

4 5. Approximately three thousand seven hundred seventy (3,770) square feet of
5 space in the west wing of the basement that is occupied by the Department of Central
6 Services on June 1, 1995;

7 6. Approximately two thousand one hundred (2,100) square feet of space in the
8 center of the basement that is occupied by the Department of Central Services and the
9 Office of State Finance on June 1, 1995;

10 7. Approximately six hundred (600) square feet of space in the center of the
11 basement that is occupied by the Department of Central Services on June 1, 1995;

12 8. Approximately two thousand three hundred one (2,301) square feet of space in
13 the center of the basement that is occupied by the Department of Central Services on
14 June 1, 1995; ~~and~~

15 9. ~~Upon completion of the project authorized in Section 321 of this title,~~
16 ~~approximately~~ Approximately twelve thousand five hundred sixty (12,560) square feet of
17 space in the west wing of the first floor that is occupied by the Office of the Attorney
18 General on June 1, 2001; provided, upon the Office of the Attorney General vacating such
19 space, any renovations thereto shall be made in such a manner as to ensure preservation
20 and maintenance of the cultural and historic integrity of the Capitol; and

21 10. Upon completion of the project authorized in Section 332 of this title, all space
22 in the west wing of the second floor that is occupied by the Supreme Court, all space in

1 the north wing of the second floor that is occupied by the Court of Criminal Appeals and
2 any other space in the State Capitol Building that is occupied by the appellate courts
3 prior to relocation to the Wiley Post Historical Building; provided, the Supreme Court
4 and the Court of Criminal Appeals shall continue to occupy the courtrooms located in the
5 west and north wings of the second floor upon such occasions as the Chief Justice of the
6 Supreme Court deems necessary and appropriate.

7 B. The authority of the Legislature to allot space may be delegated to the President
8 Pro Tempore of the Senate and the Speaker of the House of Representatives. Each
9 House of the State Legislature shall have the exclusive charge of the purchase, use,
10 allotment, and disposition of its respective chambers, committee rooms, fixtures,
11 furniture, supplies, and apparatus, and shall be responsible for the use and preservation
12 of same.

13 SECTION 2. This act shall become effective November 1, 2009
