COMMITTEE SUBSTITUTE FOR ENGROSSED SENATE BILL NO. 671 - By:
ALDRIDGE of the Senate and WRIGHT (JOHN) of the House.

An Act relating to sunset; amending 74 O.S. 2001, Sections 3904, as amended by Section 1, Chapter 26, O.S.L. 2003 and 3905, as amended by Section 1, Chapter 93, O.S.L. 2004 (74 O.S. Supp. 2008, Sections 3904 and 3905), which relate to the termination of certain statutory entities; re-creating certain entities; modifying list of statutory entities subject to re-creation; and modifying termination date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

- 1 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3904, as amended by
2 Section 1, Chapter 26, O.S.L. 2003 (74 O.S. Supp. 2008, Section 3904), is amended to
3 read as follows:
- 4 Section 3904. The following statutory entities and their successors shall be
5 terminated on July 1, ~~2009~~ 2013, and all powers, duties and functions shall be abolished
6 one (1) year thereafter:
