COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1778 - By: JONES, HILLIARD AND MCDANIEL (JEANNIE) of the House.

An Act relating to the State Board of Education; reappropriating and redesignating a certain amount of appropriations for Academic Achievement Awards purposes; reappropriating and redesignating a certain amount of appropriations for certain SoonerStart Early Intervention Program services; making appropriations exempt from budget and category limits; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. REAPPROPRIATION AND REDESIGNATION The amount of
2 Two Million Two Hundred Four Thousand Thirty-seven Dollars (\$2,204,037.00), of the
3 original appropriation of Four Hundred Thirty Million Five Hundred Fifty-four
4 Thousand One Hundred Twenty-eight Dollars (\$430,554,128.00), appropriated to the
5 State Board of Education by Section 6, Chapter 92, O.S.L. 2008, from any monies not
6 otherwise appropriated from the General Revenue Fund of the State Treasury, for the
7 fiscal year ending June 30, 2009, for support of public school activities and allocated in
8 Section 1, Chapter 264, O.S.L. 2008, for Education Leadership Oklahoma, is hereby
9 reappropriated and redesignated for the purpose of Academic Achievement Awards. If,
10 on the date this act is approved, any of the amount originally appropriated, as adjusted

1 by expenditures, encumbrances and transfers, results in an unencumbered balance less
2 than the reappropriated and redesignated amount, that reappropriated and redesignated
3 amount is reduced to the unencumbered amount.

4 SECTION 2. REAPPROPRIATION AND REDESIGNATION The amount of
5 One Million Three Hundred Fifty-four Thousand Three Hundred Twenty-nine Dollars
6 (\$1,354,329.00) of the original appropriation of Four Hundred Thirty Million Five
7 Hundred Fifty-four Thousand One Hundred Twenty-eight Dollars (\$430,554,128.00),
8 appropriated to the State Board of Education by Section 6, Chapter 92, O.S.L. 2008, from
9 any monies not otherwise appropriated from the General Revenue Fund of the State
10 Treasury, for the fiscal year ending June 30, 2009, for the support of public school
11 activities and allocated in Section 1, Chapter 264, O.S.L. 2008, for Staff Development, is
12 hereby reappropriated and redesignated for the purpose of funding direct services of the
13 SoonerStart Early Intervention Program. If, on the date this act is approved, any of the
14 amount originally appropriated, as adjusted by expenditures, encumbrances and
15 transfers, results in an unencumbered balance less than the reappropriated and
16 redesignated amount, that reappropriated and redesignated amount is reduced to the
17 unencumbered amount.

18 SECTION 3. The appropriations made by this act shall not be subject to fiscal year
19 agency budget and category limitations.

20 SECTION 4. It being immediately necessary for the preservation of the public
21 peace, health and safety, an emergency is hereby declared to exist, by reason whereof
22 this act shall take effect and be in full force from and after its passage and approval.
