AS INTRODUCED

An Act relating to the J.D. McCarty Center for Children with Developmental Disabilities; making an appropriation; stating purpose; authorizing certain expenditures; requiring budgeting in certain categories and amounts; providing for duties and compensation of employees; limiting salary of the Director; requiring compliance with budgetary limitations; exempting certain federal funds from expenditure limitations; providing exception; providing lapse dates; requiring and prohibiting certain budget and expenditure procedures; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the J.D. McCarty Center for Children with Developmental Disabilities from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2011, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to

1 perform the duties imposed upon the J.D. McCarty Center for Children
2 with Developmental Disabilities by law.

3 SECTION 2. The J.D. McCarty Center for Children with
4 Developmental Disabilities is hereby authorized to expend from the
5 American Recovery and Reinvestment Act Fund ("490") the sum of
6 _____ Dollars (\$0.00) or so much as may be necessary to
7 perform the duties imposed on the J.D. McCarty Center for Children
8 with Developmental Disabilities by law.

9 SECTION 3. For the fiscal year ending June 30, 2011, the J.D.
10 McCarty Center for Children with Developmental Disabilities shall
11 budget all funds in the following categories and amounts:

14 SECTION 4. The duties and compensation of employees, not
15 otherwise prescribed by law, necessary to perform the duties imposed
16 upon the J.D. McCarty Center for Children with Developmental
17 Disabilities by law shall be set by the Director. The salary of the
18 Director shall not exceed _____ Dollars (\$0.00) per
19 annum, payable monthly for the fiscal year ending June 30, 2011.
20 The J.D. McCarty Center for Children with Developmental
21 Disabilities, for the fiscal year ending June 30, 2011, shall be
22 subject to the following budgetary limitations, except as may be
23 authorized pursuant to the provisions of Section 3603 of Title 74 of
24 the Oklahoma Statutes:

1 from the FY-11 budget work program and after such revision has been
2 approved by the Office of State Finance.

3 SECTION 6. This act shall become effective July 1, 2010.

4 SECTION 7. It being immediately necessary for the preservation
5 of the public peace, health and safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
