HOUSE JOINT RESOLUTION NO. 1084 - By: MILLER of the House.

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to Section 21 of Article X of the Constitution of the State of Oklahoma; modifying membership of the State Board of Equalization; providing for chair of Corporation Commission as member; providing ballot title; and directing filing.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF
THE 2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

1 SECTION 1. The Secretary of State shall refer to the people for their approval or
2 rejection, as and in the manner provided by law, the following proposed amendment to
3 Section 21 of Article X of the Constitution of the State of Oklahoma to read as follows:
4 Section 21. A. There shall be a State Board of Equalization consisting of the
5 Governor, State Auditor, State Treasurer, Lieutenant Governor, Attorney General, State
6 Inspector and Examiner ~~and~~ the President of the Board of Agriculture and the chair of
7 the Corporation Commission. The duty of said Board shall be to adjust and equalize the
8 valuation of real and personal property of the several counties in the state, and it shall
9 perform such other duties as may be prescribed by law, and they shall assess all railroad
10 and public service corporation property.

1 B. Should the Offices of State Examiner and Inspector and State Auditor be
2 consolidated in the Office of State Auditor and Inspector, the State Auditor shall be
3 replaced as a member of the State Board of Equalization by the State Auditor and
4 Inspector and the Superintendent of Public Instruction shall be added as a member
5 thereof. Should the offices not be so consolidated, the membership shall remain the same
6 as provided in subsection A of this section and the Superintendent of Public Instruction
7 shall not be added to the membership.

8 SECTION 2. The Ballot Title for the proposed Constitutional amendment as set
9 forth in SECTION 1 of this resolution shall be in the following form:

12 **THE GIST OF THE PROPOSITION IS AS FOLLOWS:**

13 This measure amends the Oklahoma Constitution. It amends Section 21 of Article
14 10. This section creates the State Board of Equalization. This measure would
15 cause the chair of the Corporation Commission to be added as a member of the
16 State Board of Equalization.
