Senate Bill No. 1168

ENGROSSED SENATE BILL NO. 1168 - By: FORD of the Senate and COODY of the House.

An Act relating to schools; creating the Legislative Task Force on Achieving Classroom Excellence; stating duties; providing for membership, appointment, designation of officers, quorum, staff support, and travel reimbursement; requiring report of findings and recommendations by certain deadline; providing for noncodification; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law not to be codified in the  
2 Oklahoma Statutes reads as follows:

3 A. There is hereby created until November 30, 2009, the Legislative Task Force on  
4 Achieving Classroom Excellence. The task force shall conduct a comprehensive review of  
5 the Achieving Classroom Excellence Act of 2005 and subsequent amendments.

6 B. The task force shall study topics including, but not limited to, the following:

7 1. The requirements of the Achieving Classroom Excellence Act of 2005, as  
8 amended;

9 2. Possible alternative assessments and alternative methods for meeting the  
10 requirements of the Achieving Classroom Excellence Act of 2005, as amended;

- 1           3. Policies to reduce the high school drop-out rate;
- 2           4. Policies to enhance completion of the requirements for high school graduation
- 3 and increase postsecondary program enrollment and completion; and
- 4           5. The potential of blending services offered by common education, career and
- 5 technology education, and higher education.
- 6           C. The task force shall consist of ten (10) members as follows:
- 7           1. The Chair of the Senate Committee on Education;
- 8           2. The Vice Chair of the Senate Committee on Education;
- 9           3. The Chair of the Senate Appropriations Subcommittee on Education;
- 10          4. One member of the Senate Committee on Education, appointed by the Minority
- 11 Leader of the Senate;
- 12          5. One member of the Senate Appropriations Subcommittee on Education,
- 13 appointed by the Minority Leader of the Senate;
- 14          6. The Chair of the House Committee on Common Education;
- 15          7. The Chair of the House Committee on Higher Education and Career Tech;
- 16          8. The Chair of the House Appropriations and Budget Subcommittee on Education;
- 17          9. One member of the House Committee on Common Education or the House
- 18 Committee on Higher Education and Career Tech, appointed by the Minority Leader of
- 19 the House of Representatives;
- 20          10. One member of the House Appropriations and Budget Subcommittee on
- 21 Education, appointed by the Minority Leader of the House of Representatives.

1 D. The Chair of the Senate Committee on Education shall serve as the chair of the  
2 task force. The Chair of the House Committee on Common Education shall serve as vice-  
3 chair of the task force. Appointments to the task force shall be made by July 1, 2009.  
4 Meetings of the task force shall be held at the call of the chair of the task force. Members  
5 shall serve at the pleasure of their appointing authorities. A majority of the members of  
6 the task force shall constitute a quorum to transact business, but no vacancy shall impair  
7 the right of the remaining members to exercise all of the powers of the task force. A  
8 vacancy on the task force shall be filled by the original appointing authority. Staff  
9 support for the task force shall be provided by the staff of the Senate and the House of  
10 Representatives. The State Department of Education, Oklahoma Department of Career  
11 and Technology Education, and the Oklahoma State Regents for Higher Education shall  
12 provide support and information as requested by the task force.

13 E. Members of the task force shall receive no compensation for serving on the task  
14 force, but shall receive travel reimbursement in accordance with Section 456 of Title 74  
15 of the Oklahoma Statutes.

16 F. The task force shall submit a report by November 30, 2009, to the Governor, the  
17 President Pro Tempore of the Senate, and the Speaker of the House of Representatives.  
18 The report shall include findings and recommendations for any statutory or regulatory  
19 changes necessary to improve the Achieving Classroom Excellence Act of 2005.

20 SECTION 2. This act shall become effective July 1, 2009.

1 SECTION 3. It being immediately necessary for the preservation of the public  
2 peace, health and safety, an emergency is hereby declared to exist, by reason whereof  
3 this act shall take effect and be in full force from and after its passage and approval.
