11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. There is hereby appropriated to the Supreme Court  
13 from any monies not otherwise appropriated from the General Revenue  
14 Fund of the State Treasury for the fiscal year ending June 30, 2011,  
15 the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as  
16 may be necessary to perform the duties imposed upon the Supreme  
17 Court and the Court of Civil Appeals by law.

18 SECTION 2. For the fiscal year ending June 30, 2011, the  
19 Supreme Court shall budget all funds in the following categories and  
20 amounts:

8       SECTION 3. The duties and compensation of employees, not  
9 otherwise prescribed by law, necessary to perform the duties imposed  
10 upon the Supreme Court by law shall be set by the Supreme Court  
11 Justices by majority vote.

12       SECTION 4. The duties and compensation of employees, not  
13 otherwise prescribed by law, necessary to perform the duties imposed  
14 upon the Court of Civil Appeals by law shall be set by the Court of  
15 Civil Appeals, subject to the approval of the Supreme Court.

16       SECTION 5. The Supreme Court and the Court of Civil Appeals for  
17 the fiscal year ending June 30, 2011, shall be subject to the  
18 following budgetary limitations on full-time-equivalent employees,  
19 excluding active retired judges, and expenditures, excluding  
20 expenditures for capital and special projects and excluding lawful  
21 expenditures from the State Judicial Fund, except as may be  
22 authorized pursuant to the provisions of Section 3603 of Title 74 of  
23 the Oklahoma Statutes:
