ENGROSSED SENATE BILL NO. 226 - By: JOHNSON (MIKE) AND MYERS of the Senate and MILLER AND MARTIN (SCOTT) of the House.

( Oklahoma Health Care Authority – appropriation - budgeting - duties and compensation - salary of Administrator - effective date )

1 SECTION 1. There is hereby appropriated to the Oklahoma Health Care Authority  
2 from any monies not otherwise appropriated from the General Revenue Fund of the State  
3 Treasury for the fiscal year ending June 30, 2010, the sum of \_\_\_\_\_  
4 Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed  
5 upon the Oklahoma Health Care Authority by law.

6 SECTION 2. For the fiscal year ending June 30, 2010, the Oklahoma Health Care  
7 Authority shall budget all funds in the following categories and amounts:

5 The agency shall develop outcome-based performance measures for each budget  
6 category.

7 SECTION 3. The duties and compensation of employees, not otherwise prescribed  
8 by law, necessary to perform the duties imposed upon the Oklahoma Health Care  
9 Authority by law shall be set by the Administrator of the Oklahoma Health Care  
10 Authority. The salary of the Administrator shall not exceed \_\_\_\_ Dollars (\$0.00) per  
11 annum, payable monthly for the fiscal year ending June 30, 2010. The Oklahoma Health  
12 Care Authority for the fiscal year ending June 30, 2010, shall be subject to the following  
13 budgetary limitations, except as may be authorized pursuant to the provisions of Section  
14 3603 of Title 74 of the Oklahoma Statutes:
