5 ENGROSSED HOUSE BILL NO. 2319 - By: Murphey and Pittman of the House
6 and Sykes of the Senate.

7 An Act relating to state government; amending 74 O.S. 2001,
8 Section 3921, which relates to the termination of certain
9 entities; providing for termination of task forces or
10 similar advisory entities; prescribing time period for
11 termination; and providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3921, is
14 amended to read as follows:

15 Section 3921. A. 1. Any joint resolution or bill enacted
16 after February 1, 1993, creating or establishing advisory bodies
17 including, but not limited to, task forces, boards, commissions, and
18 councils, which creation or establishment is not codified in the
19 Oklahoma Statutes, shall terminate the first day of the first
20 regular session of the next Oklahoma Legislature unless the joint
21 resolution or bill specifies an earlier or later termination date.

22 2. Any advisory bodies created by bill or joint resolution
23 prior to February 1, 1993, which creation or establishment is not
24 codified in the Oklahoma Statutes, shall be terminated unless the
25 advisory body is codified in the next decennial compilation of
26 Oklahoma laws.

1 B. 1. Effective January 1, 1994, except as otherwise provided
2 by this subsection, advisory bodies including, but not limited to,
3 task forces, boards, commissions and councils created or established
4 by simple resolutions or concurrent resolutions passed by the
5 Legislature or either house thereof shall terminate the first day of
6 the first regular session of the next Oklahoma Legislature, unless
7 such simple or concurrent resolution specifies an earlier
8 termination date.

9 2. Any such advisory body created prior to January 1, 1991, by
10 a simple or concurrent resolution passed by the Legislature or
11 either house thereof is hereby terminated.

12 C. If a task force or similar advisory body created pursuant to
13 a codified section of law does not conduct at least one meeting or
14 issue its final report within three (3) years from the date upon
15 which the section of law creating the task force or similar advisory
16 body becomes effective, the task force or advisory body shall cease
17 to have any authority to conduct any business and shall be
18 considered terminated by operation of law at the expiration of the
19 three-year period.

20 SECTION 2. This act shall become effective November 1, 2010.
