ENGROSSED HOUSE JOINT RESOLUTION NO. 1084 - By: Miller of the House
and Jolley of the Senate.

(proposed amendment to Section 21 of Article X -
Constitution - State Board of Equalization - ballot title -
filing)

~~BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE:~~

SECTION 1. The Secretary of State shall refer to the people for
their approval or rejection, as and in the manner provided by law,
the following proposed amendment to Section 21 of Article X of the
Constitution of the State of Oklahoma to read as follows:

Section 21. A. There shall be a State Board of Equalization
consisting of the Governor, State Auditor, State Treasurer,
Lieutenant Governor, Attorney General, State Inspector and Examiner
and, the President of the Board of Agriculture and the chair of the
Corporation Commission. The duty of said Board shall be to adjust
and equalize the valuation of real and personal property of the
several counties in the state, and it shall perform such other

1 duties as may be prescribed by law, and they shall assess all
2 railroad and public service corporation property.

3 B. Should the Offices of State Examiner and Inspector and State
4 Auditor be consolidated in the Office of State Auditor and
5 Inspector, the State Auditor shall be replaced as a member of the
6 State Board of Equalization by the State Auditor and Inspector and
7 the Superintendent of Public Instruction shall be added as a member
8 thereof. Should the offices not be so consolidated, the membership
9 shall remain the same as provided in subsection A of this section
10 and the Superintendent of Public Instruction shall not be added to
11 the membership.

12 SECTION 2. The Ballot Title for the proposed Constitutional
13 amendment as set forth in SECTION 1 of this resolution shall be in
14 the following form:

17 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

18 This measure amends the Oklahoma Constitution. It amends
19 Section 21 of Article 10. This section creates the State Board
20 of Equalization. This measure would cause the chair of the
21 Corporation Commission to be added as a member of the State
22 Board of Equalization.
