5 SENATE BILL NO. 643 - By: Coffee of the Senate and Benge of the  
6 House.

7 [ State Capitol Building - management - effective date ]

8 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

9 SECTION 1. AMENDATORY 73 O.S. 2001, Section 15.1, as  
10 amended by Section 1, Chapter 89, O.S.L. 2006 (73 O.S. Supp. 2008,  
11 Section 15.1), is amended to read as follows:

12 Section 15.1 A. The Legislature shall have management and  
13 control of the following space in the State Capitol Building:

14 1. The space on the third, fourth, fifth and sixth floors;

15 2. The space in the basement that is occupied by the  
16 Legislature on June 1, 1995;

17 3. Approximately six thousand nine hundred thirty-nine (6,939)  
18 square feet of space in the west wing of the first floor that is  
19 occupied by the Department of Libraries on June 1, 1995;

20 4. Approximately six thousand six hundred ninety-one (6,691)  
21 square feet of space in the west wing of the basement that is  
22 occupied by the Department of Libraries and the Department of  
23 Central Services on June 1, 1995;

1           5. Approximately three thousand seven hundred seventy (3,770)  
2 square feet of space in the west wing of the basement that is  
3 occupied by the Department of Central Services on June 1, 1995;

4           6. Approximately two thousand one hundred (2,100) square feet  
5 of space in the center of the basement that is occupied by the  
6 Department of Central Services and the Office of State Finance on  
7 June 1, 1995;

8           7. Approximately six hundred (600) square feet of space in the  
9 center of the basement that is occupied by the Department of Central  
10 Services on June 1, 1995;

11          8. Approximately two thousand three hundred one (2,301) square  
12 feet of space in the center of the basement that is occupied by the  
13 Department of Central Services on June 1, 1995; ~~and~~

14          9. ~~Upon completion of the project authorized in Section 321 of~~  
15 ~~this title, approximately~~ Approximately twelve thousand five hundred  
16 sixty (12,560) square feet of space in the west wing of the first  
17 floor that is occupied by the Office of the Attorney General on June  
18 1, 2001; provided, upon the Office of the Attorney General vacating  
19 such space, any renovations thereto shall be made in such a manner  
20 as to ensure preservation and maintenance of the cultural and  
21 historic integrity of the Capitol; and

22          10. Upon completion of the project authorized in Section 332 of  
23 this title, all space in the west wing of the second floor that is

1 occupied by the Supreme Court, all space in the north wing of the  
2 second floor that is occupied by the Court of Criminal Appeals and  
3 any other space in the State Capitol Building that is occupied by  
4 the appellate courts prior to relocation to the Wiley Post  
5 Historical Building; provided, the Supreme Court and the Court of  
6 Criminal Appeals shall continue to occupy the courtrooms located in  
7 the west and north wings of the second floor upon such occasions as  
8 the Chief Justice of the Supreme Court deems necessary and  
9 appropriate.

10 B. The authority of the Legislature to allot space may be  
11 delegated to the President Pro Tempore of the Senate and the Speaker  
12 of the House of Representatives. Each House of the State  
13 Legislature shall have the exclusive charge of the purchase, use,  
14 allotment, and disposition of its respective chambers, committee  
15 rooms, fixtures, furniture, supplies, and apparatus, and shall be  
16 responsible for the use and preservation of same.

17 SECTION 2. This act shall become effective November 1, 2009.
