9 AS INTRODUCED

10 An Act relating to the University Hospitals
11 Authority; making an appropriation to the University
12 Hospitals Authority; stating purpose; providing for
13 duties and compensation of employees; requiring
14 compliance with and providing budgetary limitations;
15 providing lapse dates; requiring and prohibiting
16 certain budget procedures; providing an effective
17 date; and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. There is hereby appropriated to the University
20 Hospitals Authority from any monies not otherwise appropriated from
21 the General Revenue Fund of the State Treasury for the fiscal year
22 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
23 much thereof as may be necessary to perform the duties imposed upon
24 the University Hospitals Authority by law.

1 SECTION 2. The duties and compensation of employees, not
2 otherwise prescribed by law, necessary to perform the duties imposed
3 upon the University Hospitals Authority by law shall be set by the
4 University Hospitals Authority. The University Hospitals Authority
5 for the fiscal year ending June 30, 2010, shall be subject to the
6 following budgetary limitations, except as may be authorized
7 pursuant to the provisions of Section 3603 of Title 74 of the
8 Oklahoma Statutes:

Full-time-equivalent Employees	0.0

11 SECTION 3. Appropriations made by this act, not including
12 appropriations made for capital outlay purposes, may be budgeted for
13 the fiscal year ending June 30, 2010 (hereafter FY-10) or may be
14 budgeted for the fiscal year ending June 30, 2011 (hereafter FY-11).
15 Funds budgeted for FY-10 may be encumbered only through June 30,
16 2010, and must be expended by November 15, 2010. Any funds
17 remaining after November 15, 2010, and not budgeted for FY-11, shall
18 lapse to the credit of the proper fund for the then current fiscal
19 year. Funds budgeted for FY-11 may be encumbered only through June
20 30, 2011. Any funds remaining after November 15, 2011, shall lapse
21 to the credit of the proper fund for the then current fiscal year.
22 These appropriations may not be budgeted in both fiscal years
23 simultaneously. Funds budgeted in FY-10, and not required to pay
24 obligations for that fiscal year, may be budgeted for FY-11, after

1 the agency to which the funds have been appropriated has prepared
2 and submitted a budget work program revision removing these funds
3 from the FY-10 budget work program and after such revision has been
4 approved by the Office of State Finance.

5 SECTION 4. This act shall become effective July 1, 2009.

6 SECTION 5. It being immediately necessary for the preservation
7 of the public peace, health and safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval.
