6 AS INTRODUCED

7 An Act relating to amusements and sports; amending 3A
8 O.S. 2001, Section 616, as last amended by Section
9 16, Chapter 329, O.S.L. 2008 (3A O.S. Supp. 2008,
10 Section 616), which relates to the Oklahoma State
Athletic Commission Revolving Fund; increasing
amounts allowed to be retained in fund; providing an
effective date; and declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 3A O.S. 2001, Section 616, as last
15 amended by Section 16, Chapter 329, O.S.L. 2008 (3A O.S. Supp. 2008,
16 Section 616), is amended to read as follows:

17 Section 616. A. There is hereby created in the State Treasury
18 a revolving fund for the Oklahoma State Athletic Commission to be
19 designated the "Oklahoma State Athletic Commission Revolving Fund".
20 The fund shall be a continuing fund, not subject to fiscal year
21 limitations, and shall consist of all monies received from fees,
22 administrative fines, reimbursements, bond proceeds, and sale of
23 materials, and shall include grants and gifts, pursuant to the
24 Oklahoma State Athletic Commission Act. All monies accruing to the

1 credit of said fund are hereby appropriated and may be budgeted and
2 expended by the State Department of Health as directed by the
3 Commission for the purpose of implementing the provisions of the
4 Oklahoma State Athletic Commission Act; provided, revenue in excess
5 of ~~Three Hundred Thousand Dollars (\$300,000.00)~~ Seven Hundred Fifty
6 Thousand Dollars (\$750,000.00) during any fiscal year shall be
7 deposited to the credit of the General Revenue Fund of the State
8 Treasury. Expenditures from said fund shall be made upon warrants
9 issued by the State Treasurer against claims filed as prescribed by
10 law with the Director of State Finance for approval and payment.

11 B. The "Professional Boxing Licensing Revolving Fund" created
12 for the Department of Health is hereby abolished. On July 1, 2008,
13 any unencumbered funds remaining in the Professional Boxing
14 Licensing Revolving Fund shall be transferred to the credit of the
15 Oklahoma State Athletic Commission Revolving Fund. Any unexpended
16 funds remaining in the Professional Boxing Licensing Revolving Fund
17 after November 1, 2008, shall be transferred to the credit of the
18 Oklahoma State Athletic Commission Revolving Fund.

19 SECTION 2. This act shall become effective July 1, 2009.

20 SECTION 3. It being immediately necessary for the preservation
21 of the public peace, health and safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
